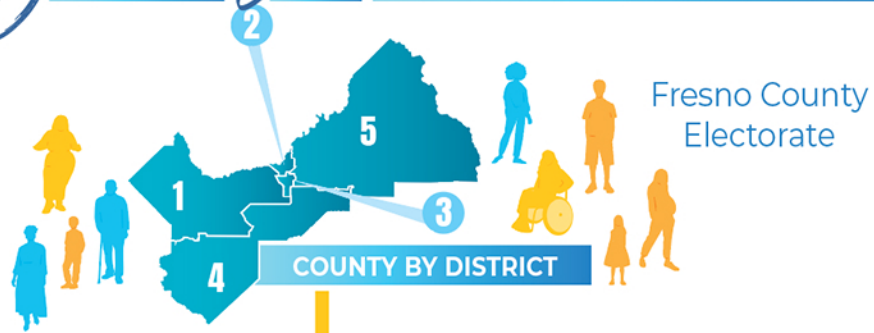

I want to thank you for taking a few minutes to review and consider some of the amazing work being done in Fresno County over the last year! If you are part of the Fresno County family, please read this report with pride and to gain an understanding of the many things we do! If you are part of our diverse community, a review of this report will give you insight on how your County government is serving you and our entire community in ways you may never have known.

### Resilience

During this past Fiscal Year (FY) 2022-23, **the County of Fresno weathered its fair share of challenges (literally and figuratively), from the unpredictable economy to record winter storm activities** which challenged our infrastructure, roads, and safety, and required an “all hands-on deck” approach from many departments and agencies.

I am especially proud of the hard work of our **“Flood Response Operations Group” or as we called ourselves, the FROG**. I am especially proud of awards received in the CAO's office including “Epic” awards from the California Public Information Officials (CAPIO) for our communication and marketing efforts and an Achievement Award from the National Association of Counties (NaCo) for our fentanyl awareness campaign.

### The unhoused and ARPA

*I'm grateful to be part of this beautiful and diverse county with talented and hard-working people!*

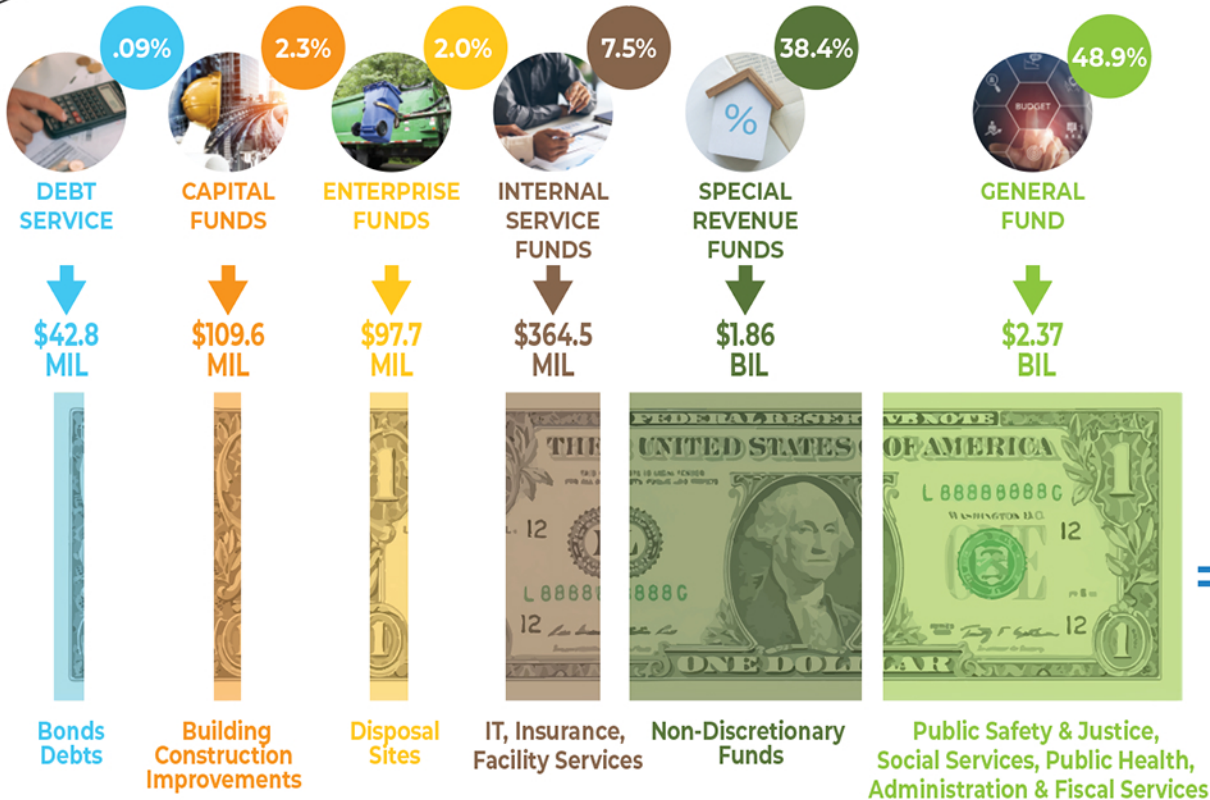

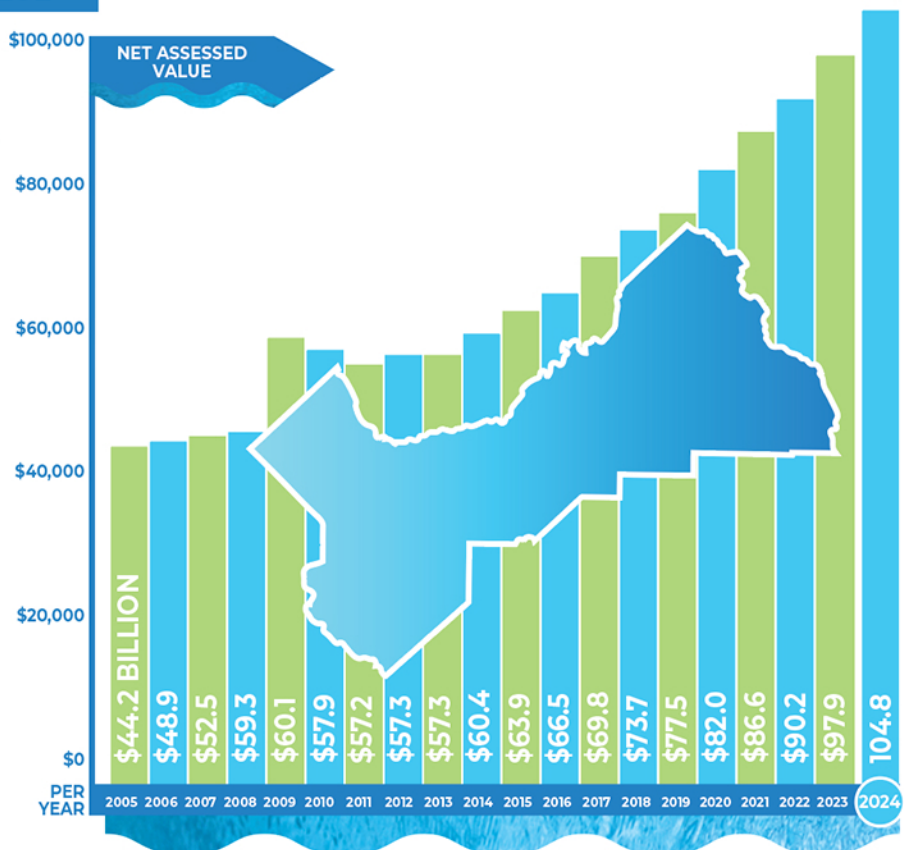

## FRESNO COUNTY NET ASSESSED VALUE

Secured Property Taxes and Property Tax In-Lieu of Vehicle License Fees (VLF) are the largest source of General Fund revenues. These taxes are determined on the assessed value of real and personal property within the County. The chart below is a 20-year history of property tax values in the County of Fresno.

The 2023-24 Preliminary Net Assessment Roll of \$104.8 billion increased approximately \$7 billion or 7% over the prior year's roll value. While this increase is slightly less than last year's increase of \$7.6 billion (8.5%), it is still significant. 2014 marked the first year since 2008 in which the County realized sizable increases in value. Prior to the last two years, the average annual increase over the previous 8 years had been approximately 5%.

Although there was substantial growth in Net Assessed Value in 2023, the County continues to prepare for the impacts of the cooling housing market.

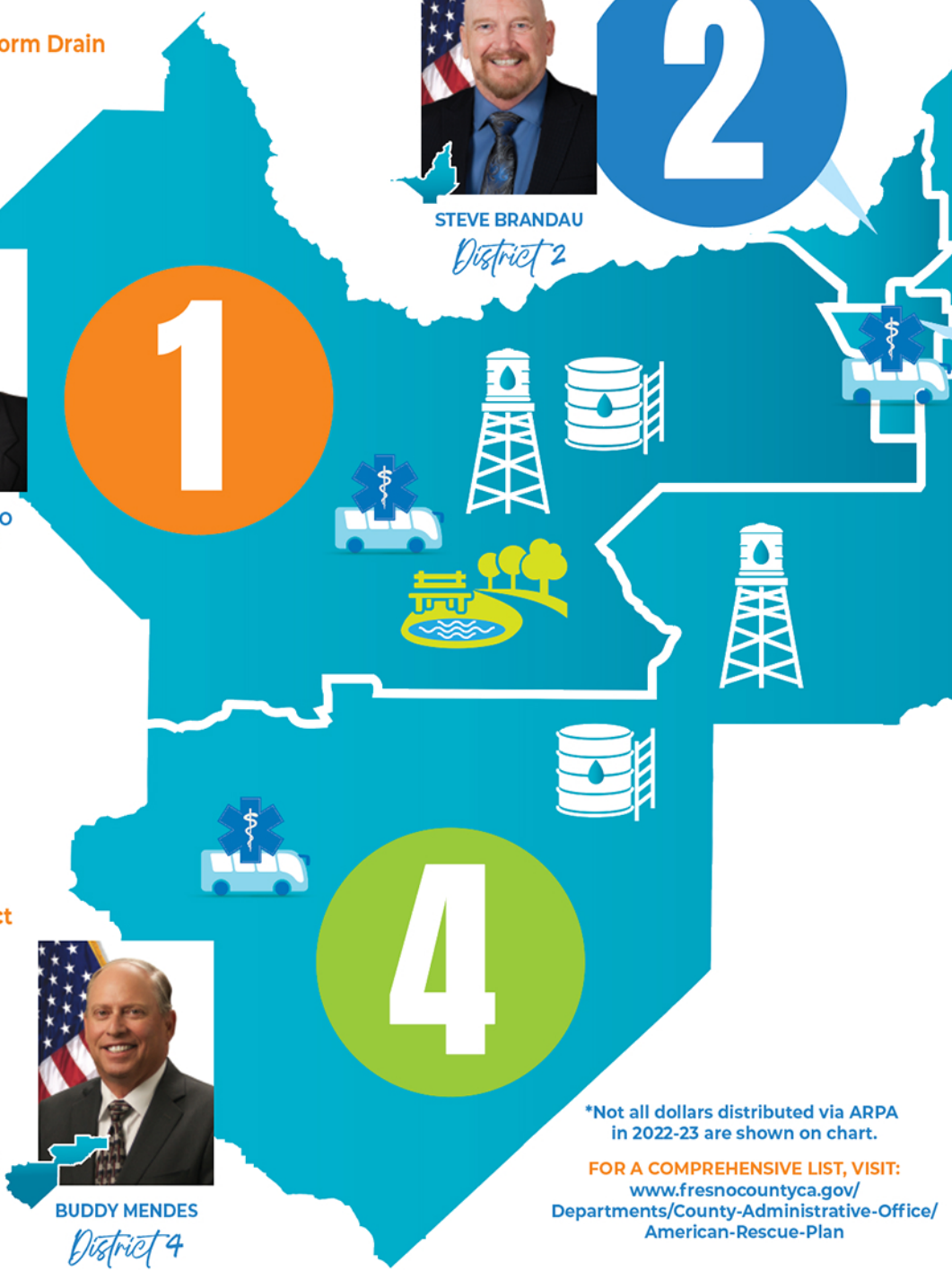

# Assisting the Unhoused and Housing Insecure



**IN THE LAST 5 YEARS,** Fresno County has led the way on a collaborative response to serve both the unhoused and the housing insecure.

The County is the administrative agency for the Fresno Madera Continuum of Care (FMCoC) with a staff member presiding as the chair.



In 2019, Fresno County, in coordination with its 15 cities, **ADOPTED PRIORITIES TO ASSIST THE UNHOUSED.**

In March 2022, the County of Fresno, in partnership with the 15 incorporated cities, **REVISED THE COMMUNITYWIDE HOMELESS PRIORITIES** in collaboration with the County's departments of Behavioral Health (DBH), Public Health (DPH), and Social Services (DSS).



## MASTER LEASING PROGRAM

DBH contracts with RH Community Builders to provide a Master Leasing Program. This program is a **transitional housing program that serves people with a serious mental illness who are experiencing homelessness or at-risk of homelessness** that are also connected to DBH or its contracted providers for Specialty Mental Health Services. **The Department provides 68 leased units for this target population.**



## MULTI-FAMILY HOUSING PROGRAM PERMANENT SUPPORTIVE HOUSING

The County shall continue to seek funding to continue to grow DBH's already extensive permanent supportive housing inventory. **Currently, DBH has built 307 permanent supportive housing units with hundreds more planned.**

DBH has secured approximately **\$18 million (No Place Like Home, Prop 2) over the last 3 years to support the unhoused, or housing insecure and need-based supportive services.**

**\$7.2 million has been allocated for 5 years of supportive housing services in the county** (aside from the funding for the actual housing).



## MULTI-AGENCY ACCESS POINT (MAP) PROGRAM

The County of Fresno funds the Multi-Agency Access Point (MAP) Program to assist persons in Fresno County with access/linkages to services. These have ranged from mental health, substance use, housing, social services, primary care, utilities, food, etc.

The County contracts with community-based organizations to provide this program which also funds the navigators and the MAP tool. MAP does screening and offers linkages.

**The County invests approximately \$1 million annually for this program.** It's not limited to persons served by DBH/Mental Health but anyone who seeks some linkages.

# Working with F.R.O.G.

Throughout the months of January, February, and March of this year, Fresno County received substantial amounts of rain and snowfall from a record number of atmospheric rivers. Due to the impacts of both the rain and snowstorms, Fresno County's Emergency Services Director Paul Nerland proclaimed a State of Emergency on January 9, 2023, and again on March 2, 2023.

The purpose of the proclamations was to address extensive weather-related damage from the snowmelt, debris flow, and flooding throughout the County. To provide residents with accurate information, consistent messaging, and coordinated support from many agencies, Fresno County's Office of Emergency Services opened the Emergency Operations Center and convened daily in-person and virtual meetings with County departments such as the County Administrative Office, Fresno Sheriff, Public Works and Planning, Internal Services Division, Public Health, as well as CAL FIRE. This group of departments and agencies soon adopted a new acronym: FROG (Flood Response Operations Group).

The FROG also had daily briefings with the County's Department of Social Services and agency partners such as the CHP, CalTrans, PG&E, Southern California Edison, National Weather Service, Sierra National Forest Service, CalOES, the Army Corps of Engineers, the Kings River Water Association, cities, and elected officials throughout the state.

In early January, the County activated an emergency web page to provide residents with updated maps and links on road closures, traffic, weather, sandbags, evacuation warnings, among other pertinent information. A new URL, [www.fresnocountyemergency.com](http://www.fresnocountyemergency.com), was subsequently introduced to provide an easier way for County residents to find this information. The FROG shared up-to-date warnings and information with the public through press releases, social media platforms, videos, PSAs, and press briefings.



As the subsequent snowmelt resulted in dangerous conditions in both the Kings and San Joaquin Rivers, the Fresno County Sheriff closed them to protect lives. Fresno County produced many PSAs in English, Spanish, Hmong, and Punjabi, enlisting the help of elected officials to help spread the message about the dangers of the rivers.

Though the County of Fresno encountered damage to roads, property, and land from the storms, the teamwork and communication between so many County departments and agencies may have prevented further damage and loss of life.



The Roads and Maintenance Operations crew in Public Works and Planning worked almost **29,000 regular hours** and **14,000 overtime hours throughout the winter storms** to clear the snow and repair the roads.

# Agriculture and Weights and Measures



## OUTREACH & COMMUNITY EVENTS ARE KEY!

**The Ag Department obtained a new County-managed canine to use in our ongoing battle against invasive pests.** Our canine team, handler Amanda Clark and canine Rufus, identifies and inspects packages at parcel terminal facilities containing materials that may harbor invasive pests.

**These activities protect agriculture, the environment, human health and safety, and the economy.**

**Community outreach and engagement is very important at the Ag Department.** The department procured a new pop-up canopy that is both educational and colorful, drawing the public to our booth. Among other events in 2022-23, we attended the California Farmworker Foundation-sponsored **"Dia De La Familia"** in Parlier, **Earth Day's "Family KIDSFEST 2023"** at the Fresno Fairgrounds, and the **"Govaganza" job fair** at Chukchansi Park. Regardless of the event, **our goal is to educate the public about the functions of the Ag Department, listen to their concerns, answer questions, and assist in any way possible.**

We inspect weighing and measuring devices used to sell any product by weight or measure to ensure consumer protection in Fresno County. **We inspected approximately 9300 gas pumps in 2022. The gas pump compliance rate with weights and measures laws and regulations was 98%, which is better than the State average of 94%.**

One of our many functions is the enforcement of pesticide laws and regulations for the protection of the environment, property, animals, agriculture, and worker and public safety. Many of our inspectors enforce these laws and regulations along with their other duties. In a nod to the popular TV show *Magnum PI*, **we formed the Pesticide Inspection Team, or "PI Team".**

**The PI Team consists of three inspectors that focus solely on pesticide use enforcement activities.**

Since its creation in July of 2022, the PI Team alone conducted more than 650 pesticide use enforcement inspections.

**The Assessor's Office certified the 2022 Assessment Roll, reflecting economic growth for the tenth consecutive year with an increase in the assessed value of taxable property countywide.**

**The 2023-24 Preliminary Net Assessment Roll of \$104.8 billion increased approximately \$7 billion or 7% over the prior year's roll value.** Property taxes are a vital source of revenue not only to the County, but also to schools, cities, and special districts who all rely on them to provide essential services to the public they serve.

In addition, in July 2022, the **Recorder's Office moved to its beautiful new building** which provides the public new conveniences such as free parking, vital records located on the first floor, and the first of its kind in the State, a drive-through service.

The Fresno County Auditor-Controller/Treasurer-Tax Collector's (ACTTC) Office provides governmental accounting and financial services and promotes public trust by providing exemplary accounting and financial services to our public, business, and governmental customers.



Our office has extended the hours of operation during heavy collection in the months of April and December to accommodate those taxpayers unable to visit the office during standard business hours. **Please refer to our website for exact days and times.**

The primary responsibilities of the Divisions/Units of the ACTTC are:

**Tax Collection Division** – To collect secured and unsecured taxes for all County taxing agencies.

**Treasury** – The depository for County department funds and other public agencies and the investment of those funds.

**Revenue Collection Unit** – To provide a professional collection and billing service for the resolution of debts owed to the County.

**Financial Reporting & Audits Division** – To prepare the County's Annual Comprehensive Financial Report, perform internal audits of County departments, and administer the County Fraud Hotline.

**Special Accounting Division** – To calculate countywide tax rates, prepare the County's Cost Allocation Plan, process bond payments for various entities, and validate special district checks.

**General Accounting Division** – To ensure the integrity of the County's financial system and process payments of the County's obligations.

**Payroll Unit** – To process payroll for County employees on a biweekly basis and remit payments to the appropriate agencies.

**Administration Division** – To provide business support to the office.

# Behavioral Health

## PROMOTING WELLNESS IN OUR COMMUNITY



**988 Launch** - In July 2022, the National Suicide Prevention Lifeline launched a new easy-to-use three-digit number, 9-8-8. The old 1-800 number is still active, but now, anyone, anywhere in the country can call or text 988 and get crisis support. The Department of Behavioral Health (DBH) has been on a yearlong campaign to promote 988. It has used media, online ads, sporting events, community events, and schools to promote 988. The 988 call center for central California is funded by the department.

**Continued Housing** - The department continued its work in establishing more affordable and supportive housing. This past year saw the **opening of Butterfly Gardens in Clovis and Alegra Commons in Fresno**. These two developments added 117 units, bringing the total units to 656. Four more projects started construction this year and upon completion, will add 365 more units of affordable and supportive housing. Behavioral Health and support services are provided on site for some residents.

**Experiencing Hope** - To kick off May's Mental Health Awareness Month, the department **launched its first full-length documentary film**, developed fully by the department. The film focuses on real stories and experiences of local community members who have overcome challenges and inspired hope in others. The film premiered on May 3rd. The **11 stories are used to help promote hope, reduce stigma, and normalize discussions around mental health and substance use.**

**Mental Health Services Act (MHSA) Three-Year Plan** - The department undertook the development of a **new MHSA Plan by conducting 15 community forums, 15 key sector interviews, and engaging over 380 persons for input.** To access MHSA funds, this process is required every three years. This undertaking took the team around the County, with stops including Huron, Tarpey Village, Biola, Fresno State, and meetings with public safety, providers, family members, resident councils, youth, and persons served. This plan funds \$112 million in services in the coming year.

**Service Expansion** - The department funds a number of substance use and mental health services throughout Fresno County. In the past year, amid a workforce shortage, legislative changes, payment reform, and new mandates on care delivery, the **Department of Behavioral Health expanded care and services.** The increases were both in number of individuals served and the number of services. **An additional 1,000 people received care last year** than the year before along with **an increase of 5,000 sessions or units of care** from the previous year.

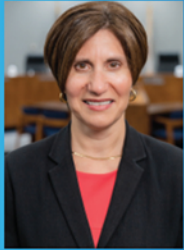

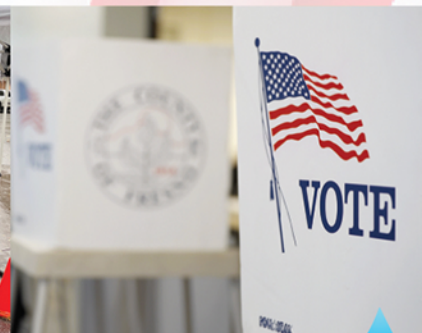

The Fresno County District Attorney's Office is the chief law enforcement agency within the County of Fresno, and the mission of the office is to pursue justice and promote public safety. Each year, the DA's Office prosecutes tens of thousands of cases that are investigated by the over two dozen law enforcement agencies within the County.

### Within the office there are 8 units:

- Misdemeanor
- Juvenile
- Felony Trial Teams
- Consumer Protection
- Domestic Violence
- Sexual Assault
- Child Abuse
- Gangs and Homicide

Each unit works tirelessly to hold those accountable who violate the law, victimize our citizens, and harm our community.

Our office regularly collaborates with our law enforcement partners at the local, state, and federal level on operations involving gun crimes, human trafficking, and fentanyl.

- Our gang unit, the **Multi Agency Gang Enforcement Consortium (MAGEC)**, celebrated its 25th anniversary in October 2022, which highlighted the incredible collaboration to eradicate gang activity in our community.
- **Operation Hands Off Our Kids (HOOK)** was a joint operation that led to 19 arrests; **Operation Safe Neighborhoods** led to 279 arrests, and **Operation Broken Bonds** ended with 18 people facing state charges for targeting the children of our community.

The DA's Office continues to lead the fight against fentanyl, filing first-degree murder charges in October against the person who allegedly sold pills resulting in a fentanyl related death. DA Smittcamp also worked with our State and Federal legislatures to create legislation that would hold drug dealers accountable for their actions. She was also a vocal supporter of AB 2365 which was signed into law in September 2022 and will provide grant funding for other counties to replicate Fresno's fentanyl education and awareness campaign.

The employees from the DA's Office are also involved in various community events such as Beautify Fresno, MADD's Walk Like MADD run, AMOR's annual food drive and Adopt-A-Family programs, the 39th Annual MLK Unity March in Downtown Fresno, Festival de los Ninos at Fresno Chaffee Zoo, and the Law Enforcement Torch Run for Special Olympics Northern California, to name a few!

In partnership with Fresno Police, Fresno Sheriff, and Fresno County Probation, the DA's Office presented a check for \$38,500 to Boys and Girls Clubs of Fresno to ensure that our youth are empowered to become productive, caring, and responsible citizens.

# Internal Services

## SERVICING DEPARTMENTS AND THE COMMUNITY



**Security screened over 84,000+ visitors at the Plaza over the last year.** On February 22, 2023, **Sergeant Carlos Perez saved the life of a customer by administering CPR for 7 straight minutes** until EMS and Fire arrived. He received a proclamation from the Board of Supervisors on March 28, 2023.

**County website modernizing** provides an enhanced user experience with an updated visual appeal and design, as well as optimization for mobile experience through its responsive design.

**Plaza Courtyard Beautification Project** saw the landscape move to more drought-resistant plants and shrubs helping to conserve water. The plaza had their **outdated cooling tower media replaced with new high efficiency media** which allows the cooling for Plaza staff and the public. **Downtown parking is now free to all County staff.**

**As part of the GO Green Initiative, our diesel vehicles now use R99 renewable diesel which is better for the environment.** The purchase of **52% of all office supplies were eco-friendly** and **over 16% of Countywide purchases of maintenance, repairs and operations supplies (MRO) were green spend.**

**STORM 2023 flood response** included: hosting the **Emergency Operations Center (EOC)**; **mobile surveillance cameras moved to key spots for 24/7 monitoring of rivers**; **hosting press conferences for the media**; **Fleet preparing two new loaders for snow removal** and performing 154 work orders for Public Works & Planning during the storm.



# Probation

## IMPLEMENTATION AND COLLABORATION FOR SIGNIFICANT GROWTH

This year, Probation implemented the Risk Assessment Services Team for both Adult and Realignment services. The team works to identify an individual's criminogenic needs, assist in the rehabilitative journey, and complete the terms of their probation successfully. Results help develop case plan goals and programming. By identifying a variety of factors, a Case Plan is created and tailored for the individual's successful transition and reintegration into the community.

In collaboration with the Fresno County Superior Court, we experienced significant growth in Pretrial Services. The Pretrial Program census doubled in size. Our Pretrial Assessment Unit reviewed over 22,000 jail bookings and completed over 11,000 Public Safety Assessment (PSA) reports. We continue to partner with local, state, and federal law enforcement agencies for community safety, proactive probation compliance contacts in the community, and collaborative operations which yield numerous probation searches, felony arrests, and firearms seized.

Deputy Probation Officers in the Juvenile Division volunteered to participate in community engagement events to support our local community. This includes participation in job fairs at local elementary schools, high schools, and universities.

The Juvenile Justice Institution focused on infrastructure improvements to include refurbishment of housing units, technology, internal landscaping, and revitalized living environments for youth. Additionally, redesigning a home intended to assist youth transitioning from custodial care to the community began. The institution continues to have strong partnerships with community-based organizations that provide services to the youth to include lived experience mentors, parenting programming, spiritual opportunities, a Boys and Girls Club, and high school and secondary educational advancement.

The James Rowland Crime Victim Assistance Center provided services to 9,070 victims of crime and in April 2023, unveiled the 2023 Victims' Memorial Quilt with an additional 22 patches. Probation personnel hired 91 new employees that completed a rigorous and thorough background process in order to provide the highest level of service to our community. Training officers facilitated 117 trainings and attended 328 training hours to enhance evidence-based services to the community.

# Public Health

## CULTIVATING A DIVERSE CULTURE IN HEALTH



The Fresno County Health Department (FCDPH) launched the Rural Mobile Health (RMH) program in February 2023.

The RMH program offers medical services at no-cost to farmworkers and residents living in the rural areas of Fresno County.

This program includes UCSF Fresno and Fresno State in collaboration with Saint Agnes Hospital.

To date, 48 clinics have been organized and completed, with over 1,700 individuals receiving medical services through the implementation of the RMH program.



This partnership also includes Community Health Workers (CHWs) from the Fresno Community Health Improvement Partnership (FCHIP) on Health, Outreach, Prevention, and Equity (HOPE) Hub.

The CHWs provide culturally sensitive health education. In addition, vision services from Tzu Chi Mobile Clinic are now included.



National Public Health Week (NPHW) was proclaimed by the Board of Supervisors on April 3 - 9, 2023.

The FCDPH provided educational sessions based on the daily themes of NPHW and highlighted the work that staff do in the community. This year's theme was Centering and Celebrating Cultures in Health, which focused on community health, violence prevention, reproductive and sexual health, mental and rural health, and nutrition. The FCDPH held "Healthy Fresno County Night" at the Fresno Grizzlies game, which included a resource fair and public health messaging.



Vince was a founding member of CUPA. The organization provides assistance to the public and other agencies by responding to emergencies such as hazardous materials spills and accidents.

Environmental Health Division Manager Vince Mendes was recognized in April by the California Certified Unified Program Agency (CUPA) Forum and received the Lifetime Achievement award.

## A NEW SHERIFF IS IN TOWN!

### In January 2023, John Zanoni was sworn in as the 26th Sheriff of Fresno County.

He began his career with the Fresno County Sheriff's Office as a 108 Reserve Deputy Sheriff in 1996 and was hired as a full time Deputy Sheriff in November of 1998. During his career, he worked in the Boating Enforcement Unit, Court Services, Detention Custody, Patrol, Uniformed Tactical Assignment, M.A.G.E.C (Multi Agency Gang Enforcement Consortium) Detective and the Search and Rescue Team. **Sheriff Zanoni looks forward to leading the Sheriff's Office to remain one of the top law enforcement agencies in the country and improving the quality of life for the people he serves.**



### Saying Goodbye to an Outstanding Colleague

In August 2022, 69-year-old Chief Forensic Pathologist Venu Gopal died in a tragic auto accident while driving on Highway 168 near Auberry.

**Doctor Gopal worked at our Coroner's Office since 1992. In 2020, he was honored as the Sheriff's Office Employee of the Year after serving as the lone forensic pathologist in the office.**

He performed approximately 350 autopsies and 500 external exams. **Doctor Gopal's work ethic was unmatched.** It was not uncommon for him to work seven days a week for months at a time.

Aside from his regular duties, he taught anatomy, physiology and forensic aspects of an autopsy to paramedics, nurses, anatomy students, criminology students, and medical assistants. He periodically hosted Emergency Room doctors during their residency for their forensic training requirements.



In December 2022, **School Resource Officer (SRO) Deputy Jaime Mendoza helped to prevent a possible shooting from occurring on the campus of Tranquillity High School.** Threatening social media posts were quickly relayed to Deputy Mendoza who immediately went to the home of the alleged suspect and contacted him. He and other deputies searched the house and located the teenager's backpack, which contained a TEC-9 pistol and a magazine. Deputies seized the gun and arrested the 15-year-old. **The Optimist Club of Greater Fresno recognized Deputy Jaime Mendoza with its annual "Respect for Law Award."**

**Female inmates inside the Fresno County Jail are given an opportunity to learn how to sew and develop valuable job skills.**

This sewing program, funded entirely by the Incarcerated Persons Welfare Fund, teaches patience and perseverance and has inspired some to pursue future careers in the sewing industry. **They have participated in community projects by donating quilts to the Fresno Veterans Affairs Hospital and Marjaree Mason Center.** The Fresno County Sheriff's Office strongly believes in improving the lives of those incarcerated and embraces opportunities to teach them useful skills that can benefit their lives and the community once out of custody.

### DSS Department Overview

The Department of Social Services (DSS) is a key safety net for the County's most vulnerable population, serving one out of every two residents. Our mission is to assist adults, children, and families to achieve health, safety, and self-sufficiency. Services provided by the Department and in collaboration with community-based organizations and partners help combat and address homelessness, food insecurity, underemployment, health coverage, and the safety and wellbeing of children and the elderly.

### Fresno County Veterans Service Office

The Fresno County Veterans Services Office (VSO) **provides vital services to veterans and their families.** Services consist of community outreach, precision guidance, and filing accurate claims for obtaining benefits and entitlements from the U.S. Department of Veterans Affairs, Department of Defense, and State and local programs. Last fiscal year, the **VSO assisted with the completion of 2,433 new claims totaling \$7,583,937 in new benefit awards approved.**

### Child Welfare Service Enhancements

The Child Welfare Services Branch is **focusing on enhancing prevention services and improving placement options for youth in Foster Care.** Fresno County has 2,294 youth in out of home placement. Currently, just under 30% of these youth are placed with relatives. **Our goal over the upcoming year is to improve family finding and supports and have at least 50% of our youth living with relatives.**

### Ending of Continuous Medi-Cal Coverage

In 2020, the Federal Government declared a public health emergency (PHE) in response to the Coronavirus outbreak and legislation was passed to provide continuous Medi-Cal coverage. **In June 2023, with the PHE ending, the Medi-Cal program is resuming its normal annual renewal process. During the next year, approximately 20,000 cases (44,000 individuals) per month will be completing their annual renewal process.** DSS is actively working with community partners and Health Care Plans to inform the public of this change and maintain Medi-Cal benefits to those eligible.

### CalSAWS

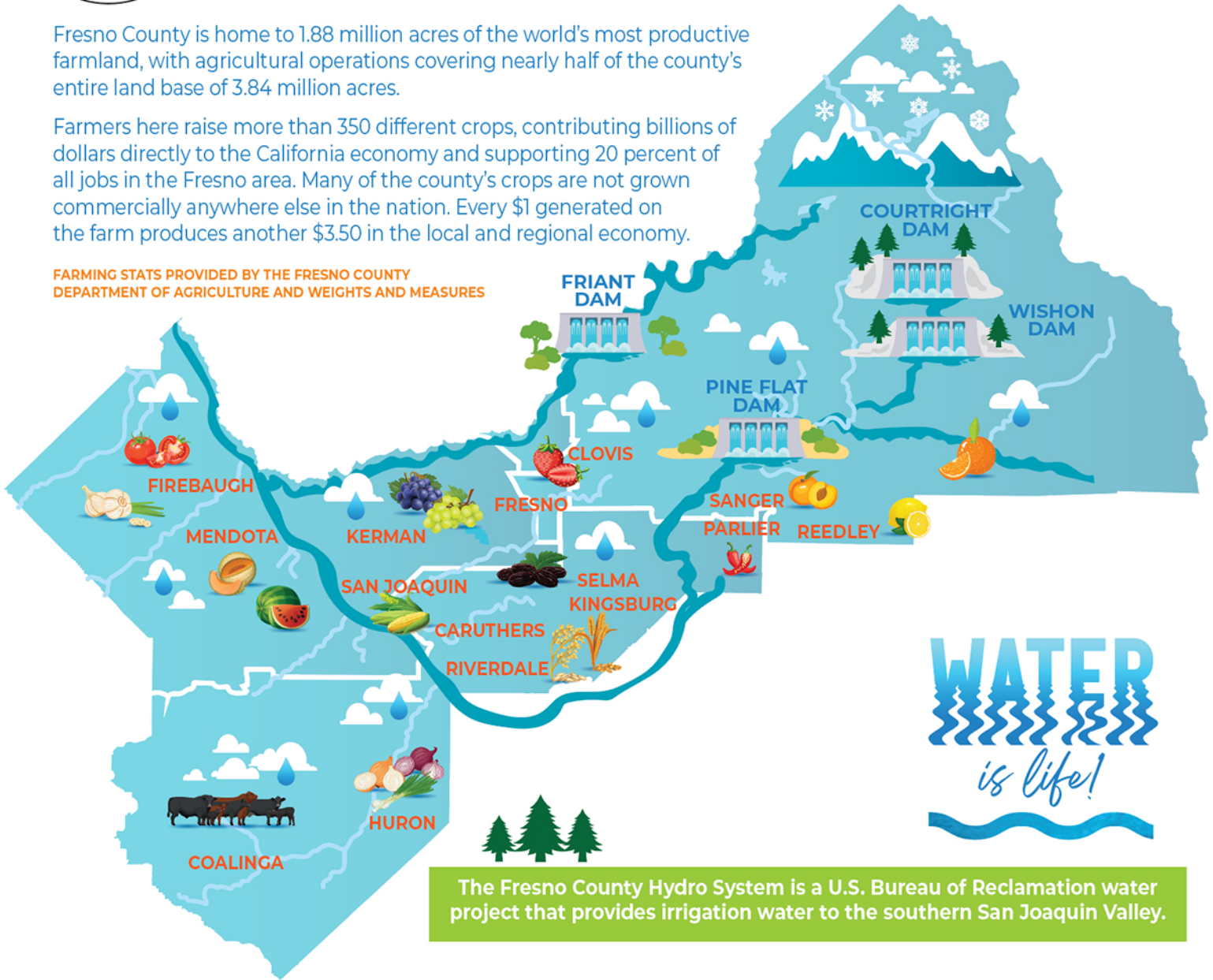


# The County of Fresno Hydro Map

Fresno County is home to 1.88 million acres of the world's most productive farmland, with agricultural operations covering nearly half of the county's entire land base of 3.84 million acres.

Farmers here raise more than 350 different crops, contributing billions of dollars directly to the California economy and supporting 20 percent of all jobs in the Fresno area. Many of the county's crops are not grown commercially anywhere else in the nation. Every \$1 generated on the farm produces another \$3.50 in the local and regional economy.
