Qhov Nqi Sib Pab Them Yog Dabtsi?

Qhov nqi sib pab them (Share of Cost) yog qhov nqi koj them txhua hli mus rau lub pab kas phais them nqi khomob ua ntej Qhov Qhoos Kas Pab Them Nqi Khomob (MISP) yuav them, nyob ntawm seb koj kev khwv nyiaj tau los licas thiab muaj khoom ntaus nqi ntau npaum cas. Qhov nqi sib pab them (SOC) no ua hauj lwm tib yam li cov nqi uas koj them txhua hli rau koj lub pab kas phais them nqi kuaj mob.

Koj them qhov nqi sib pab them (SOC) no mus rau cov chaw muaj kev pab MISP. Lwm cov nqi khomob uas koj them mus rau cov chaw tsis muaj Qhov Qhoos Kas MISP txhua hli, nrog rau tej uas koj cia li mus yuav los siv huvsu, yuav tsis muab xam ua qhov nqi sib pab them rau hauv Qhov Qhoos Kas MISP.

Cov kev khomob yuav tsum yog los hauv: Chaw nyob ntawm Qhov

- Ib Lub Tsev Khomob Community Medical Center (CMC), hauv qhov chaw kuaj mob muaj xwm txheej ceev, los sis cov chaw kuaj mob nruab hnub
- Yog ib tug kws khomob nyob hauv "Central California Faculty Medical Group (CCFMG) tuaj khomob rau hauv Tsev Khomob CMC cov chaw kuaj mob los sis hauv chaw kuaj mob muaj xwm txheej ceev hauv Tsev Khomob CMC

Cov neeg ua hauj lwm rau MISP mam sau ntawv tuaj qhia koj yog:

- Koj tsis muaj feem txais tau Qhov Qhoos Kas MISP;
- Koj muaj feem txais tau Qhov Qhoos Kas MISP uas tsis muaj Qhov Nqi Sib Pab Them li; los sis
- Koj muaj feem txais tau Qhov Qhoos Kas MISP nrog rau Qhov Nqi Sib Pab Them thiab koj yuav tau them koj Qhov Nqi Sib Pab Them.

Koj Qhov Nqi Sib Pab Them (SOC) no yog txiav txim los ntawm seb koj qhov nyiaj taus los qis tshaj los sis siab tshaj ntawm qhov kev tau nyiaj los rau hauv koj lub tsev.
