It was not until I attended a workshop with Communities for a New CA that I learned this process was going on. How is it that latinos are the majority but are not taken into consideration nor targeted to participate? I have never seen anything on local media where most of my spanish speaking community gets their information. How my community is at the moment, it is divided. We need a new map that ensures we are one that I am confident that Fresno Inclusive Families Map protects my community. The streets like Willow are in bad condition and worse have no lights so I cannot walk past sundown. I want to ensure we have a representative that hears us and advocates for us. I urge that you communicate with us when a map is decided because information is seldom passed down to us. I hope you make the right decision for a better Fresno County.
