I want to urge the commissioners and county supervisors to redraw the maps in a way that uplifts all working families, including the ones in North Fresno. The current map currently has me in district 2. My current supervisor has not proved to me that he has my best interest in hand. As a Hispanic that understands what it's like to be taken advantage of in this country, I also don't feel that the current lines do not do their justice in uplifting the families of essential workers county-wide. We cannot afford another 10 years of another map remotely close to the current. Please support a map that will set the stage to better support working, essential and the families that need it the most. The Fresno Inclusive Families Maps will do exactly that and I ask each of you to seriously consider it and/or model it for your final decision.

Today, the County is over 50% Latino but has only one Latino on the Board of Supervisors. The County is over 70% of people of color when you group the Latino community, the Black community, the Hmong community, the Punjabi community, the Muslim community, and others. And yet the Board of Supervisors is 80% White. The map should be updated to reflect our dynamic and changing populations. We cannot and will not wait another 10 years for something to happen, now is the time. I am supporting The Inclusive Families Coalition maps because they ensure our communities are kept together.
