The enclosed Vessel Property Statement is required of you by Section 441 of the Revenue and Taxation Code. The statement must be completed according to the instructions and filed with the Assessor on or before April 1. Failure to file it during the time provided will compel the Assessor to estimate the value of your property from other information in his possession and add a penalty of 10% as required by Section 463 of the Code.

In an effort to reduce processing time and postage costs for you and our office, this Vessel Property Statement will be the only document you will need to file for as long as you own the boat. Until further notice, we will be making our assessments from year to year based on information in our possession.

Your immediate attention to this matter will facilitate our efforts to arrive at a fair and equitable assessment of your boat. You will be receiving a tax bill at a later date based on such information.
