III. Approval of draft minutes from the November 15th BHB meeting

The November 15th, 2023 meeting minutes were approved

IV. Department of Behavioral Health (DBH) Update; Director, Susan Holt

DBH Director, Susan Holt began the Department Update presentation with the mention of many acknowledgments for the month of December that included health topics, national historic days of remembrance and some cultural celebrations.

An extra thank you was given to all the support received on the following item that went forth to our Fresno County Board of Supervisors

A. General Updates: DBH Events, Board of Supervisors (BOS) items and legislation <u>Board of Supervisors Items</u>

Resolution approved December 12th that will delay the implementation of expanded grave disability criteria associated with the passing of Senate Bill 43 to allow a planful process with stakeholders.

- Implementation delayed until January 2026
- Most counties across the state have delayed implementation except for two counties

Legislative Updates – Item of interest

AB 1047

- Related to gun purchasing law
- Requires the Department of Justice to create a develop a platform for individuals to voluntarily add their name to a registry that involves advising a licensed behavioral health clinician by email during a 10-day waiting period of the attempt to purchase the firearm
- The purpose of registry is for a third party to potentially intervene
- Concerns from the Department include the process moving through email and does not specify what actions are expected by the local county Department of Behavioral Health, as well as no support in funding associated with this Bill amendments brought forth

Deaths by suicide for Fresno County

The number of deaths by suicide for November 2023 is 10. Interestingly the same number for years 2022 and 2020. This data continues to be monitored closely. More discussion to come in 2024 permitting Prop 1 passing and the impact to prevention dollars.

Electronic Health Record and Payment Reform Updates

- The number of counties participating has grown from 21 counties to 23 counties
- Technical problems with the invoice generator have been addressed and has resolved any known cashflow issues thus far
- Met with the Mental Health Contractors Association and Substance Use Disorders Provider Association and will continue to meet regularly to partner in a strategic way to come up with solutions while navigating this post payment reform era
- The State of California of Health Care Services have heard the struggles from Behavioral Health Directors and Provider Associations and have brought in a thirdparty consultant to provide technical assistance

B. Crisis mobilization status

- Implementation of new Medi-Cal model of expanded mobile crisis intervention
- Current Crisis Intervention team consists of a co-response of law enforcement and a licensed mental health clinician when requested by law enforcement

- New medical model will require 24/7 availability of Behavioral Health professional with a required specific response time
- The goal for a system collaborative model will be a cross system partnership deciding how to work together at the point of crisis response to achieve the best outcomes for all
- New mobile crisis benefits verses current crisis intervention services is that individuals currently must already be involved in a program in order to receive crisis services opposes now anyone in the community can receive services
- Minimum of a two-person team who has received a required core training in crisis assessment and deliver the initial face-to-face crisis assessment onsite

Question from BHB member – Does the crisis phone line have a system for recording data on the calls for individuals Response – HIPPA law was referenced and mentioned that current law allows communication of collateral information amongst crisis clinician and peace officer
