A limited number of awards will be available to Fresno County qualified mental health service providers and award recipients may receive at least \$11,500¹ towards the repayment of educational loans.

- ❖ Fresno County Loan Repayment Program (FCLRP) application must be submitted via the online application system by the new extended due date of March 8, 2024. Applications submitted after March 8, 2024, at 5pm PST will not be accepted.

This program requires that eligible Fresno County qualified mental health service provider applicants work in a "hard-to-fill" position as defined by Fresno County DBH. Please refer to the Central Regional Partnership- Fresno County Loan Repayment Program Application and Program Guide for a listing of "hard to fill/retain" positions identified to meet our critical workforce needs.

Program overview and requirements:

- The Loan Repayment Program is a component of Fresno County's Workforce Education and Training (WET) Program managed by the California Mental Health Services Authority, which reviews eligible applications and generates agreements with the awardees.
- Lligible applicants must work in the Fresno County Mental Health Plan (MHP). Options include:
 - Employed by and working in a County-operated mental health setting.
 - Employed by and working in a contracted, community-based school-based mental health agency or program under contract with the County Mental Health Plan.
 - Working under contract as an Individual or Group provider delivering services, on average, at least 25 hours per week to Department of Behavioral Health Mental Health Plan persons served
- Awardees are required to work for 12 months in a hard-to-fill or hard-to-retain position in Fresno County's MHP before the funds will be applied to loans.

¹ Only applicable towards qualifiable educations loans (see "D. Qualifying and Non-Qualifying Educational Loans"). If loan amount is less than \$11,500 that amount will be awarded, if selected. If any remaining funds remain it may be equitably distributed to the awardees from all the rounds resulting in an increased award amount towards repayment of educational loans in exchange for a 12-month service obligation.
