KOJ MUAJ CAI:

- Kom raug saib taus, muaj kev ywj pheej thiab nyob li tib neeg
- Tsis pub raug mob raug ntsaj xws li muab hlua pav zawm yam tsis tsim nyog los yog zawm ceev dhau, tau tshuaij noj, txhob raug cais, raug tsim txom thiab tsis saib xyuas
- Tau txais cov ntaub ntawv hais txog txoj kev kho koj thiab muaj feem koom tes nrhiav kev kho koj
- Tso cai los yog tsis tso cai rau kho, tshwj yog txoj cai teev tau tias yog ib qho xwm txheej ceev los yog txoj cai pom tau tias tsis muaj peev xwm txiav txim siab tau
- Tau kev pab los ntawm *client-center services* uas tsim los pab kom tau li koj lub hom phiaj, tau kev pab lwm yam, daws kev txhawj, pab kom muaj lub zog, txhawb, qhuas thiab pab kev xiam oob khab
- Tau cov kev pab kho kom muaj peev xwm nyob tau ib leeg
- Tau kev kho mob yam tsis tu ncua
- Tau cov kev pab thiab ntaub ntawv sau/hais ua hom lus koj to taub thiab haum (sensitive) rau koj kev

coj (cultural sensitive) thiab kev xav tau

- Khaws thiab siv koj li khoom ntiag tug, xam tag nrog cov khoom siv hauv tsev dej (toilet articles) tib si
- Muaj qhov chaw cia khoom rau koj ib leeg siv
- Khaws thiab siv cov nyiaj koj muaj yuav khoom me ntsis
- Siv tau xov tooj hu tawm thiab teb cov xov tooj uas hu tuaj rau koj
- Sau tau ntawv-muaj ntawv sau thiab stamps- xa tawm thiab txais cov ntaub ntawv yam tsis pub qhib
- Hnav koj cov khaub ncaws
- Tawm sib ntsib/sibtham, koom zej zog kev ua si, khaiv/dhia yoj cev thiab lwm yam kev ua si lom zem
- Ntsib cov neeg tuaj xyuas txhua hnub
- Ntsib thiab tau kev pab los ntawm tus neeg hais cai rau neeg mob (patient-advocate) uas tsis muaj feem cuam nrog kev qhuab ntuas (clinical) los yog kev tuav/lis ntaub

ntawv rau tus neeg uas tau txais kev pab kho mob hlwb

- Coj thiab ua kev cai dab qhuas ywj siab
- Koom tes nrog cov kev pab txhawb nqa kev kawm ntawv uas tsim nyog
- Tsis pub raug kev puas tsuaj los ntawm kev ua ub ua no (hazardous procedures)
- Thiab lwm yam cai uas muaj nyob hauv cov kev cai ij choj (law or regulation)
