Problem List User Guide

- **Purpose:** To facilitate continuity of care through accessibility to an all-inclusive list of problems that will easily identify the person served' s care needs.
 - Includes current diagnoses, along with key health and social determinants of health and wellness.
 - Will replace the treatment plan in most cases with the exception of some EPSDT services i.e. TBS, ICC, IHBS, STRTP,
 - SUD services will still require a treatment plan.
 - Exception: NTP/OTP services are exempt from problem list requirements.
- **Contents:** Contains a list of symptoms, conditions, diagnoses, and/or risk factors that will be identified through screening, assessment, psychiatric evaluation, crisis encounter, or other types of service encounters with treatment providers.
 - Diagnoses and corresponding codes identified by provider practicing within their scope.
 - Including Z-codes/diagnostic specifiers from the DSM-5, if applicable.
 - Problems or illnesses identified by provider, practicing within their scope, if any.
 - Problems or illnesses identified by individual or significant support person, if any.
 - Name, title of provider that identified, added, or resolved the problem **along** with the date the problem was identified, added, or resolved.
- **Who completes the Problem List:** Providers responsible for the individual's care create and maintain the Problem List.
 - This includes diagnoses identified by Licensed Practitioners of the Healing Arts (LPHA) (licensed/waivered clinicians, doctors, nurse practitioners, registered nurses, clinical pharmacists, clinical psychologists, physician assistants).
 - Identified concerns by the person served and/or significant support persons involved in care.
 - Issues identified by other service providers including those by non-LPHA staff, i.e. peer support specialists, AOD counselors, case managers, rehabilitation specialists. Which includes the use of ICD-10 codes **Z55-Z65**.
 - **Note: Only staff practicing within their scope and competence may update problems using ICD 10/SNOMED codes, both mental health/physical health. Entries into the problem list are based on direct identification by the provider or based on reports by another provider and/or person served or support persons that may be addressed as part of treatment. The problem list is not solely a list of diagnoses provided by the direct treatment provider.**
- **When to update the Problem List:**
 - Providers shall identify/add/resolve problems from Problem List when there are relevant changes for the person served.
 - Updated within a reasonable time frame after problem is identified.

- **Where to update the Problem List:**

For Avatar users:

- The identified problems are added/resolved within the form named **Problem List**.
- The output of the form is located by entering **Problem List Viewer** in the search form field.

For non-Avatar users:

- The DBH Problem List is a standardized form which shall be used by all providers and cannot be altered/customized to fit each provider's needs and/or EHR.

- **How to update the Problem List:**

- 1) Problem List form is launched from the Forms Widget on the Clinical Home View, or within the chart view
- 2) To add a problem list, click **'Add New Item'**
- 3) Complete the following information:
 - a) problem/diagnosis using ICD-10 codes,
 - b) the identifying individual, AND
 - c) the provider type (If problem is identified by someone else besides provider, indicate relationship to person served (ex. self, mother, husband))

Note: When entering physical health diagnoses into the problem list, the corresponding ICD-10 codes and diagnostic description shall be included.

 - b) The identifying individual, AND
 - c) The provider type (If identified by someone else besides provider indicate relationship to person served (ex. self, mother, husband))
