Initiatives and Local Measures on the Ballot

1. Amends Mental Health Services Act to provide additional behavioral health services. Fiscal Impact: Shift roughly \$140 million annually of existing tax revenue for mental health, drug, and alcohol treatment from counties to the state. Increased state bond repayment costs of \$310 million annually for 30 years.
