This charter amendment covers more than Squaw Valley. It would preserve all roads and communities under the jurisdiction of Fresno County. However, the community of Squaw Valley is being impacted by state and federal actions.

According to articles written over 60 years ago Squaw Valley was named by the local tribe. One supporter of Squaw Valley, as reported in the article, is an Indian woman over 100 years old who declares this area was called Squaw Valley long before the white men came to California.

Names can change but that process must be driven by the local community. Voting yes on this charter amendment allows for local voices to be heard and the history of places to be researched before sweeping changes are made. Vote yes to preserve local control.
