California law, AB 2022, forbids the use of "sq\_\_\_\_" for any place name or geographic feature. Our state legislators unanimously agreed that this derogatory and hurtful name must be removed. Local Fresno County residents recommended the replacement name, "Yokuts Valley," to honor the area's earliest residents.
