
Local control is threatened daily by the state and federal government. Recently there have been attempts to change the names of schools, communities, streets and lakes without the consent of those who live, work and are directly impacted by these decisions.

Since the founding of Fresno County, in 1856, the naming of geographical areas was performed by residents and their elected local government. A yes vote on this charter amendment affirms this process.

This charter amendment, if passed, will send a clear message to the Board of Supervisors, Sacramento, and Washington; the voters of Fresno County want decisions related to name changes to remain at the local level.

Voting Yes on this charter amendment keeps the power of naming areas, with the local voters of Fresno County.
