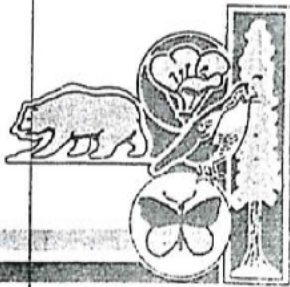

ARTICLES OF INCORPORATION OF CLOVIS FIRE FIGHTERS, INC.

I. The name of this corporation is Clovis Fire Fighters, Inc.

II. (A) This corporation is a nonprofit mutual benefit corporation organized under the nonprofit Mutual Benefit Corporation Law. The purpose of this corporation is to engage in any lawful act or activity for which a corporation may be organized under such law.

(B) The specific purpose of this corporation is to serve as a labor organization for Clovis fire fighters with tax-exempt status pursuant to Internal Revenue Code Section 501(c)(5) and Revenue and Taxation Code Section 23701a: to improve members' conditions of employment and to assure no net earnings inure to any member's benefit.

III. The name and address in the State of California of the Corporation's initial agent for service of process is Robert E. Wallace, 1552 Morris Avenue, Clovis, CA 93612.

IV. The name of the unincorporated association which is being incorporated is Clovis Fire Fighters Association.

V. The unincorporated association whose name is set forth in Article IV of these Articles of Incorporation is being incorporated by the filing of these Articles.

VI. Notwithstanding any of the above statements of purposes and powers, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the specific purpose of this corporation.
