This tax will impose \$28,000,000 every year on the people of Clovis with no end date. Perhaps you think your share of that burden is well worth paying, given the promise of continuing and improving emergency services in your city. We agree that safety services are important, and if you feel that this is a cause worth giving money towards, we applaud your generosity and your desire to contribute to your community.
