**NOTICE OF DATE FIXED FOR SUBMITTING ARGUMENTS ON THE SANGER UNIFIED SCHOOL DISTRICT GENERAL OBLIGATION BOND MEASURE**

NOTICE IS HEREBY GIVEN to the qualified electors of the Sanger Unified School District of Fresno County, California, that in accordance with the provisions of the Education Code of the State of California, an election will be held on November 5, 2024 within the District, at which election the following measure shall be submitted to the qualified electors of the District and voted upon:

To continue Sanger Unified student success and reduce overcrowding by building/ completing new schools; providing facilities for college/ career preparation; upgrade vocational/ career/ classrooms/ labs/ athletics/ dual credit pathways and online learning technology; improve health, safety and security systems; shall Sanger Unified School District's measure authorizing \$175,000,000 in bonds at legal interest rates, levying \$60 per \$100,000 assessed valuation, raising \$10 million annually for issued bonds through maturity, requiring audits, citizens' oversight, all money used locally, be adopted?

Arguments for or against the measure may be submitted to the Fresno County Clerk/Elections office at 2221 Kern St., Fresno, CA 93721, no later than Friday, July 12, 2024, by 5:00 pm. Paper copies of arguments must be submitted with original signatures, as well as by email to [clerk-elections@fresnocountyca.gov](mailto:clerk-elections@fresnocountyca.gov) in MS Word format. No argument shall exceed 300 words in length. Arguments may be submitted by the legislative body, or any member or members of the legislative body authorized by that body, or any individual voter who is eligible to vote on the measure, or bona fide association of citizens, or any combination of voters and associations. If an argument is signed by more than five persons, the names of only the first five persons signing, determined by the order in which their signatures appear, shall be printed with the argument.

Only one argument for and one argument against each measure will be selected for printing and distribution to the voters. Preference and priority in selection will be given in the order named: (1) The legislative body, or member or members of the legislative body authorized by that body; (2) The individual voter or bona fide association of citizens, or combination of voters and associations, who are the bona fide sponsors or proponents of the measure; (3) Bona fide associations of citizens; (4) Individual voters who are eligible to vote on the measure. Any argument submitted shall not be changed after Friday, July 12, 2024, by 5:00 pm.

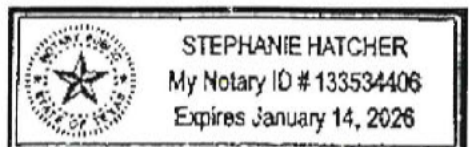
