Measure P is a \$2.7 billion blunder that will severely limit Fresno's ability to keep its citizens safe.

Measure P will raise the sales tax rate in the City of Fresno to 8.35%, which will unfairly burden struggling middle and lower income families for the next 30 years.

We support better parks, but Measure P will direct an estimated \$2,743,918,948.00 to City parks, trails and other programs while providing no additional funding to hire new police officers and firefighters. It doesn't provide one penny to rescue failing communications systems, build new fire stations or replace police cars wobbling along with over 200,000 miles.

Measure P would also transfer control of much of the decision-making process from our elected Mayor and Council to an appointed commission with no accountability to the voters and no requirements for fiscal or management expertise.

In fact, Measure P could reduce funding for police, fire and other needs because it would tie elected officials' hands by freezing current parks spending at 2017-2018 levels.

Measure P would allocate \$190 million of your tax money to arts and culture. Shouldn't we be hiring police officers and firefighters before we fund public art, particularly art we may find offensive?

Measure P would not build parks and other facilities throughout the City. The unelected Parks Commission determines the highest need areas that would get the vast majority of the money.

Please join us, the Fresno Firefighters' and Police Officers' Associations, the Fresno Chamber of Commerce, the Fresno County Lincoln Club and many, many others in voting NO on Measure P.

We can do better. Vote No on Measure P and we will bring a balanced measure back to you that funds Fresno's police, fire, public safety, parks and other vital services.
