Measure P makes Fresno a better, safer place by investing in parks, trails and recreation programs. It focuses on fixing, maintaining and upgrading Fresno's parks and will improve parks and park access in every neighborhood of the City.

Measure P implements the Parks Master Plan, which found over \$275 million is needed just to repair and improve our current parks and facilities after years of neglect. The Plan was developed through years of study and input from thousands of Fresnans and approved unanimously by the City Council.

Don't be fooled: Measure P does not reduce funding for public safety. In fact, it frees up more money from the City's general fund to support other priorities, such as police and fire protection. And it makes our parks and neighborhoods safer by reducing crime, graffiti and homelessness in parks and funding park rangers to patrol parks.

Measure P guarantees local funding for Fresno's parks, raising an estimated \$37.5 million per year. It'll cost the average household just \$3.25 each month – and groceries and medicine are exempt. Plus, it would ensure visitors and non-Fresno residents pay their fair share.

And it also includes strict citizen oversight to guarantee transparency and fiscal accountability. It ensures that the money is spent on the intended purposes – and can't be diverted for pet projects by politicians or special interests.

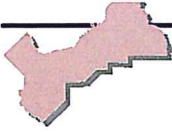
