

**NOTICE OF DATE FIXED FOR SUBMITTING ARGUMENTS ON THE PINE RIDGE ELEMENTARY SCHOOL DISTRICT GENERAL OBLIGATION BOND MEASURE**

NOTICE IS HEREBY GIVEN to all qualified electors in the County of Fresno, California that on Tuesday, November 6, 2018, there will be submitted to the voters the following measure:

“To improve the quality of education; modernize media center to support 21 st century learning; renovate/replace outdated classrooms, restrooms and school facilities; and make health, safety and security improvements; shall Pine Ridge Elementary School District issue \$5,300,000 of bonds at legal rates, generating on average \$354,000 annually as long as bonds are outstanding at a rate of approximately 3 cents per \$100 assessed value, with annual audits, independent citizens’ oversight, no money for salaries and all money staying local?”

Arguments for or against the measure may be submitted to the Fresno County Clerk/Elections, 2221 Kern St., Fresno, CA 93721, no later than Wednesday, August 15, 2018 by 5:00 pm. Paper copies of arguments must be submitted with original signatures, as well as by email at [clerk-elections@fresnocountyca.gov](mailto:clerk-elections@fresnocountyca.gov) in MS Word format. No argument shall exceed 300 words in length. Arguments may be submitted by the legislative body, or any member or members of the legislative body authorized by that body, or any individual voter who is eligible to vote on the measure, or bona fide association of citizens, or argument submitted. If an argument is signed by more than five persons, the names of only the first five persons signing, determined by the order in which their signatures appear, shall be printed with the argument.

Only one argument for and one argument against each measure will be selected for printing and distribution to the voters. Preference and priority in selection will be given in the order named: (1) The legislative body, or member or members of the legislative body authorized by that body; (2) The individual voter or bona fide association of citizens, or combination of voters and associations, who are the bona fide sponsors or proponents of the measure; (3) Bona fide associations of citizens; (4) Individual voters who are eligible to vote on the measure. Any argument submitted shall not be changed after August 15, 2018 by 5:00 pm.

ALL ARGUMENTS submitted shall be verified in substantially the following form:
