Rebuttal to Argument in favor of Measure D

In **2008**, Central voters approved a school bond for **\$152 Million** with the promise that the school district would “construct, equip, and furnish” a **new high school**. The School Board stated the tax money would be used for more than 110 projects, some of which have never been started.

In **2016**, the School Board said they needed another Bond Measure for **\$87.3 Million** to complete projects from 2008, and again, to construct a **new high school**. Voters approved that bond.

Now, in **2020**, the Board wants to saddle taxpayers with yet another bond, this one for **\$120 Million**, to, among other things, **complete the high school**. Their Argument in Favor fails to mention that over \$43 Million is earmarked for a performing arts building and pool complex.

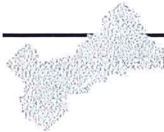
**Facts you should consider:**

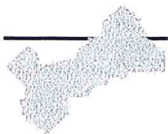

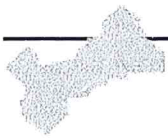

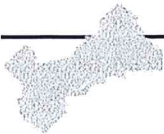
