Fresno County Votes! Deadline to Vote is Fast Approaching Reminder: Mailed ballots must be postmarked by November 3, 2020

Fresno, CA, Friday, October 23, 2020—With eleven days until the election, Fresno County voters are continuing at a record-breaking pace to make a plan and vote early. As of October 22, 2020, over 130,000 ballots have been submitted to the Fresno County Elections Department.

"This is the highest number we've had to date, and we are anticipating that this rate of return will continue over the next eleven days," said Brandi Orth, Fresno County Clerk and Registrar of Voters.

A few simple reminders:

- Fresno County voters have several ways to return their ballot.
- No matter where/how you return your ballot, all voters must remember to sign and seal their envelope!
- Every voter's signature is compared to the voter's registration record.
- Fresno County voters can return their voted and signed ballot 24/7 to any one of the 66 secure drop boxes located throughout Fresno County. The drop boxes are emptied every single day. Voters can find the locations of drop boxes here: https://www.co.fresno.ca.us/home/showdocument?id=50314
- Voters can return their voted and signed ballot in the secure self-addressed PURPLE postagepaid envelope provided with the ballot, via U. S. Mail. No additional stamp is necessary, simply
 use that PURPLE envelope, sign it and mail it. Once submitted, voters can sign up to track
 their ballot at https://WheresMyBallot.sos.ca.gov. This system provides the voter with
 notifications on the status of their vote-by-mail ballot, every step of the way. Remember:
 Mailed ballots must be postmarked by November 3, 2020.

 Office, located at 2221 Kern Street in downtown Fresno, M-F from 8:30 5:00 pm and vote
 there. *Please note that COVID-19 SAFETY MEASURES are in place.
