

MEASURE TO BE VOTED ON AND NOTICE OF DATE FIXED FOR SUBMITTING ARGUMENTS ON THE CITY OF PARLIER APPROVAL OF A SPECIAL PARCEL TAX FOR POLICE PROTECTION SERVICES MEASURE

Notice is hereby given that the following measure is to be voted on at the City of Parlier Special Municipal Election to be held in the City of Parlier, County of Fresno, on Tuesday, June 8, 2021.

Synopsis of Measure

Measure Q would repeal a provision in the Ordinance adopted by the voters at the General Election on November 8, 2016, which is the Special Parcel Tax for Public Safety (Police) Services, that would, if not repealed, result in expiration of the Parcel Tax enacted by the voters by the original Measure Q. Approval of the Measure, therefore, would have the effect of extending, but not increasing the Special Parcel Tax adopted by the voters on November 8, 2016, by repealing the provision included in the Ordinance adopted by the voters which sets that expiration date for June 30, 2022.

Arguments for or against the measure may be submitted to the Fresno County Clerk/Elections, 2221 Kern St., Fresno, CA 93721, no later than Friday, April 2, 2021, by 5:00 p.m. Paper copies of arguments must be submitted with original signatures, as well as by email to clerk-elections@fresnocountyca.gov in MS Word format. No argument shall exceed 300 words in length. Arguments may be submitted by the legislative body, or any member or members of the legislative body authorized by that body, or any individual voter who is eligible to vote on the measure, or bona fide association of citizens, or any combination of voters and associations. If an argument is signed by more than five persons, the names of only the first five persons signing, determined by the order in which their signatures appear, shall be printed with the argument.

Only one argument for and one argument against each measure will be selected for printing and distribution to the voters. Preference and priority in selection will be given in the order named: (1) The legislative body, or member or members of the legislative body authorized by that body; (2) The individual voter or bona fide association of citizens, or combination of voters and associations, who are the bona fide sponsors or proponents of the measure; (3) Bona fide associations of citizens; (4) Individual voters who are eligible to vote on the measure. Any argument submitted shall not be changed after April 2, 2021, by 5:00 p.m.
