Notice is hereby given that the following measure is to be voted on at the Consolidated Statewide General Election to be held in the City of Clovis, on Tuesday, November 8, 2022.

names of only the first five persons signing, determined by the order in which their signatures appear, shall be printed with the argument.
Only one argument for and one argument against each measure will be selected for printing and distribution to the voters. Preference and priority in selection will be given in the order named: (1) The legislative body, or member or members of the legislative body authorized by that body; (2) The individual voter or bona fide association of citizens, or combination of voters and associations; who are the bona fide sponsors or proponents of the measure; (3) Bona fide associations of citizens; (4) Individual voters who are eligible to vote on the measure. Any argument submitted shall not be changed after July 18, 2022, by 5:00 p.m.

SYNOPSIS OF MEASURE
The proposed measure would authorize a two percent (2%) increase to the transient occupancy tax (hotel tax) in the City of Clovis. If approved by the voters at the election, the transient occupancy tax rate in the City of Clovis would increase from ten percent (10%) to twelve percent (12%) beginning on January 1, 2023. This tax would be imposed only on individuals who stay overnight in hotels, inns, motels, or other short-term rentals in the City of Clovis for thirty (30) days or less. Revenues raised by the 2% tax increase would belong to the City of Clovis and would not be shared with the County, State, or any other agency. This measure is a proposed general tax measure and any new tax revenue will be deposited into the City's general fund to be used for any City operation or service, including but not limited to funding public safety services and funding other City services. The proposed tax increase contains no sunset date.
