

NOTICE OF A SPECIAL PARCEL TAX ELECTION AND NOTICE OF DATE FIXED FOR SUBMITTING ARGUMENTS FOR THE CUTLER-OROSI JOINT UNIFIED SCHOOL DISTRICT

NOTICE IS HEREBY GIVEN to the qualified electors of the Cutler-Orosi Joint Unified School District located in the County of Tulare, in the State of California, that in accordance with the provisions of the Elections Code, Government Code, and the Health and Safety Code of the State of California, an election will be held on Tuesday, the 8th day of November, 2022, for the purpose of submitting to the qualified electors of the District the measure summarized as follows:

CUTLER-OROSI JOINT UNIFIED SCHOOL DISTRICT PARCEL TAX MEASURE

To fund the operational needs of the Cutler-Orosi Joint Unified School District sports facilities and develop a recreation department to promote youth activities including sports, arts, music, and experiences that develop youth into healthy active responsible citizens. Shall the District levy a tax of \$48.00 per parcel annually with annual cost of living adjustment, initially raising approximately \$234,048 as long as the Cutler-Orosi Joint Unified School District Board oversees the program?

The proposition shall require approval of a two thirds (2/3) vote of the electorate voting on the tax.

Arguments for or against this measure may be submitted to the Tulare County Elections Division, 5951 South Mooney Boulevard., Visalia CA 93277, not later than August 2, 2022, which has been determined by the elections official to be a reasonable date based upon the time necessary to prepare and print arguments. No argument shall exceed 300 words in length.

Pursuant to Section 9162 of the Elections Code, one argument for and one argument against this

measure will be selected for printing and distribution to the voters with the sample ballot.

The elections official will also provide opportunity for rebuttal arguments to be filed no later than August 12, 2022 in accordance with Section 9167 of the Elections Code.
