**NOTICE OF DATE FIXED FOR SUBMITTING ARGUMENTS ON THE  
COALINGA HURON UNIFIED SCHOOL DISTRICT GENERAL OBLIGATION  
BOND MEASURE**

NOTICE IS HEREBY GIVEN to all qualified electors in the Coalinga Huron Unified School District, that on Tuesday, November 8, 2022, there will be submitted to the voters the following measure:

"To improve the quality of education; construct, modernize, and upgrade classrooms, restrooms and school facilities; renovate plumbing; improve drinking water; make safety/security improvements; and replace roofs; shall Coalinga Huron Joint Unified School Districts measure be adopted authorizing \$39,200,000 of bonds at legal rates, generating on average \$2,700,000 annually at a projected average rate less than 5 cents per \$100 assessed value while bonds are outstanding, with annual audits, independent oversight, no money for salaries, and all funds staying local?"

Arguments for or against the measure may be submitted to the Fresno County Clerk/Elections, 2221 Kern St., Fresno, CA 93721, no later than **Monday, August 22, 2022**, by 5:00 pm. Paper copies of arguments must be submitted with original signatures, as well as by email to [clerk-elections@fresnocountyca.gov](mailto:clerk-elections@fresnocountyca.gov) in MS Word format. No argument shall exceed 300 words in length. Arguments may be submitted by the legislative body, or any member or members of the legislative body authorized by that body, or any individual voter who is eligible to vote on the measure, or bona fide association of citizens, or any combination of voters and associations. If an argument is signed by more than five persons, the names of only the first five persons signing, determined by the order in which their signatures appear, shall be printed with the argument. Only one argument for and one argument against each measure will be selected for printing and distribution to the voters. Preference and priority in selection will be given in the order named: (1) The legislative body, or member or members of the legislative body authorized by that body; (2) The individual voter or bona fide association of citizens, or combination of voters and associations, who are the bona fide sponsors or proponents of the measure; (3) Bona fide associations of citizens; (4) Individual voters who are eligible to vote on the measure. Any argument submitted shall not be changed after **August 22, 2022, by 5:00 pm.**
