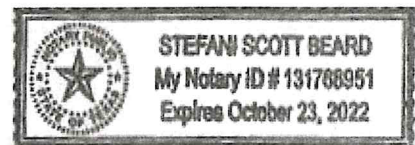

MEASURE TO BE VOTED ON AND NOTICE OF DATE FIXED FOR SUBMITTING ARGUMENTS ON THE CITY OF FRESNO VETERANS SUPPORT MEASURE

Notice is hereby given that the following measure is to be voted on at the Consolidated Statewide General Election to be held in the City of Fresno, on Tuesday, November 8, 2022.

SYNOPSIS OF MEASURE

APPROVAL OF FRESNO VETERANS SUPPORT REVENUE ENHANCEMENT ORDINANCE

The proposed ordinance would impose a 1/8 percent sales and use tax within the City of Fresno for a period of 20 years, which is estimated to raise approximately \$19.5 million annually. Proceeds would be utilized to fund capital projects and services for veterans, including (a) the construction, improvement, maintenance, acquisition, and operations of capital projects like the Fresno Veterans Memorial Auditorium and veterans' of foreign wars posts, (b) providing housing, health care, job training and other support service assistance to veterans and their families. The ordinance would require funds to be expended for capital projects and services for veterans, including housing assistance. The proposed ordinance would also have accountability measures and require the City of Fresno to create a new Veterans Commission to audit expenditures.

Arguments for or against the measure may be submitted to the Fresno County Clerk/Elections, 2221 Kern St., Fresno, CA 93721, no later than Monday, August 22, 2022, by 5:00 p.m. Paper copies of arguments must be submitted with original signatures, as well as by email to clerk-elections@fresnocountyca.gov in MS Word format. No argument shall exceed 300 words in length. Arguments may be submitted by the legislative body, or any member or members of the legislative body authorized by that body, or any individual voter who is eligible to vote on the measure, or bona fide association of citizens, or any combination of voters and associations. If an argument is signed by more than five persons, the names of only the first five persons signing, determined by the order in which their signatures appear, shall be printed with the argument.

Only one argument for and one argument against each measure will be selected for printing and distribution to the voters. Preference and priority in selection will be given in the order named: (1) The legislative body, or member or members of the legislative body authorized by that body; (2) The individual voter or bona fide association of citizens, or combination of voters and associations, who are the bona fide sponsors or proponents of the measure; (3) Bona fide associations of citizens; (4) Individual voters who are eligible to vote on the measure. Any argument submitted shall not be changed after August 22, 2022, by 5:00 p.m.
