Consider the facts, and vote YES on Measure X:

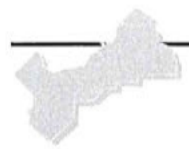
- Measure X is locally controlled, and every dollar stays here, benefitting our local schools, children, and property values.

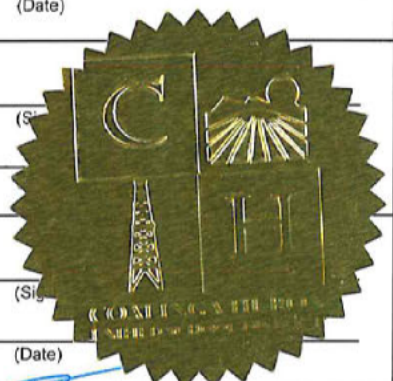

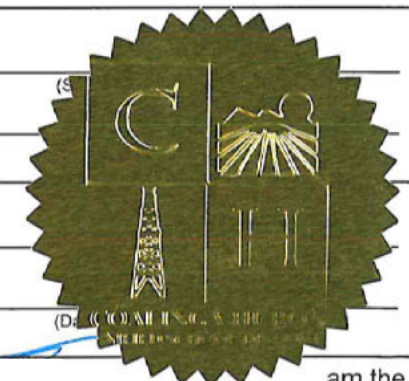
