Argument in Favor of Measure C



**Vote YES on C to repair and maintain our neighborhood streets, without increasing taxes.**

Parents and grandparents know that our streets and sidewalks aren't safe enough for our children and families. **Measure C will fill potholes, fix streets and make every neighborhood safer, before conditions get worse and repairs more expensive.**

Nearly 2/3 of roads in Fresno County were rated by independent engineers as "fair", "poor" or "very poor". Essential repairs have been put off for too long.

**Without increasing taxes, Measure C will:**

- Repair potholes
- Keep local roads in good condition
- Upgrade structurally declining bridges and overpasses
- Keep transit fares low for seniors, veterans, students and people with disabilities
- Pave roads where needed
- Create local jobs

Much of our highway system was designed in the 1960's. **Measure C is needed to improve highway safety and help address growing traffic congestion.**

Measure C will provide important funds for public transportation, including **low-cost senior transportation** and other improvements that support seniors, veterans and individuals with disabilities, to help maintain their independence and reduce the burden on families and caregivers.

Measure C also prioritizes funding in historically overlooked areas, including rural, low-income and minority communities.

**Strict accountability requirements**, including public disclosure of all spending and independent audits, ensure funds are used properly. **Every penny raised by Measure C will be spent here in Fresno County and cannot be taken by the State.**

Measure C has kept its promises to our community for 35 years. Without it, Fresno County will lose critical local funding to fill potholes and keep our streets in good condition, and lose tens of millions of dollars in available State and federal matching funds that will just go to other counties instead.

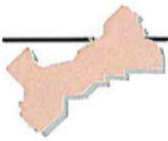
