Measure E is a special tax. Under Proposition 218 (1996), it would require a two-thirds vote for passage. It took the courts only 25 years to come up with this "loophole."

This method of getting your money has become popular this year. By our count, special tax initiatives by petition were on four local ballots in June and there are about a dozen on the November ballot. Two of the June measures dramatically crashed and burned -- a sales tax in Kings County and a parcel tax in Manhattan Beach (2 to 1 against).

Because of a retroactive provision in the Taxpayer Protection and Government Accountability Act, this will likely be the last election where these sneaky measures might succeed.

What a disgusting example of moneyed special interests (construction) hoodwinking the voters to satisfy their own greed. If the CSU System is in dire straits, it's due to their own policies.

OVERSIGHT? It's a fraud. Citizen oversight ends when votes are cast. If you could trust the board, why would you need oversight?
