

Rebuttal to the Argument Against Measure C

We've all seen the effects of cracked and crumbling streets and sidewalks in our neighborhood. **Vote YES on C: fix our streets without increasing taxes!**

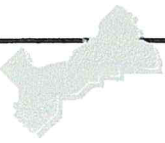
