**Training Schedule**

**2024**

**JANUARY – NIGHT SHOOT QUALIFICATION – RANGE (4 HOURS)**

January is the BOI's annual night shoot handgun qualification month. Investigators shoot in low-light or no light conditions. Investigators practice using flashlights or gun mounted lights while shooting as well. Investigators work on weapon manipulations in low-light or no light situations. This includes reloading of their weapons.

**FEBRUARY – SHOOTING FROM VEHICLES (4 HOURS)**

Investigators will receive instruction in how to shoot from a vehicle in the event that they are fired upon by a shooting suspect. Investigators will then practice what was taught.

**MARCH – FIRST AID/CPR/AED TRAINING – Juvenile Justice Center (4 HOURS)**

Investigators will receive their biannual update on First Aid/CPR/AED training.

**APRIL – BATON TRAINING - RANGE (4 HOURS)**

Investigators will receive baton / impact weapons update.

**MAY – WEAPON INSPECTIONS / QUALIFICATIONS – RANGE (4 HOURS)**

Range instructors conduct an annual inspection of all issued weapons. Investigators will complete a qualification course for their issued duty weapons.

**USE OF FORCE PSP**

Investigators will receive instruction on Use of Force. This is a POST mandated course.

**JUNE – POSITIONAL SHOOTING TRAINING – (4 HOURS)**

Investigators will receive instruction on shooting from different positions.

**JULY – BACK-UP / OFF-DUTY WEAPONS QUALIFICATIONS – RANGE (4 HOURS)**

Investigators are required by policy to shoot and qualify with their back-up/off-duty weapons if different than their duty weapons. This is done annually.

**AUGUST – DEFENSIVE TACTICS TRAINING – RANGE (4 HOURS)**

Investigators will receive instruction on arrest and control holds. This is a POST mandated class.

**SEPTEMBER – FIREARMS MALFUNCTIONS AND MANIPULATIONS – RANGE (4 HOURS)**

Investigators receive instruction on how to fix their weapons in the event of a malfunction.

**OCTOBER – MAKE UPS – RANGE (4 HOURS)**

October is our make up month. Investigators who missed range training, specifically PSP mandated training, will come to the range to complete their training for the month.

**NOVEMBER – FIREARMS QUALIFICATION – RANGE (4 HOURS)**

Investigators will shoot a handgun qualification course.
