## CRIMINAL CHARGES FILED IN PAIR OF UNRELATED WEEKEND DUI COLLISIONS THAT CAUSED MULTIPLE DEATHS

The Fresno County District Attorney's Office has filed criminal charges against Jose Hernandez and Michael Merritt-Hutchins for a pair of unrelated collisions this past weekend that resulted in three deaths.

Jose Carlos Hernandez (22, of Fresno) has been charged in a Felony Complaint with:

- 1. Gross Vehicular Manslaughter While Intoxicated [P.C. 191.5(a)];
- 2. Driving with a 0.08% Blood Alcohol Level Causing Injury [V.C. 23153(b)];
- 3. Driving Under the Influence Causing Injury [V.C. 23153(a)]; and
- 4. Leaving the Scene of an Accident Causing Death [V.C. 20001(b)(2)].

Mr. Hernandez is alleged to have struck and killed bicyclist James Raby on Saturday.

Mr. Hernandez is currently in custody at the Fresno County Jail. He faces a potential sentence of up to fifteen (15) years in custody if convicted of the charges. He is scheduled for Arraignment on Wednesday, December 13, 2017, at 8:30 a.m. in Department 34 of the Fresno County Superior Court.

Michael Robert Merritt-Hutchins (25, of Fresno) has been charged in a Felony Complaint with:

- 1. Gross Vehicular Manslaughter While Intoxicated [P.C. 191.5(a)];
- 2. Gross Vehicular Manslaughter While Intoxicated [P.C. 191.5(a)];
- 3. Driving with a 0.08% Blood Alcohol Level Causing Injury [V.C. 23153(b)]; and
- 4. Driving Under the Influence Causing Injury [V.C. 23153(a)].

Mr. Merritt-Hutchins is alleged to have struck and killed Fresno Bee carrier Daniel Mendez and his wife Ramona Mendez on Saturday.

Mr. Merritt-Hutchins is currently in custody at the Fresno County Jail. He faces a potential sentence of up to twelve (12) years in custody if convicted of the charges. He is scheduled for

Arraignment on Wednesday, December 13, 2017, at 8:30 a.m. in Department 30 of the Fresno County Superior Court.

These cases are being prosecuted by the Office's DUI Vertical Prosecution Unit.
