Drug Traffickers Charged for the Transportation of Fentanyl for Purposes of Sale

The Fresno County District Attorney's Office has filed charges against Brian Rangel (21, of Everett, Washington) and Martin Velazquez (29, of Lynnwood, Washington), for their involvement in transporting fentanyl and being in unlawful possession of firearms.

It is alleged that on August 15th, 2022, a Fresno County Sheriff's Deputy performed a traffic stop on a car near Interstate 5 and Russell Avenue in Firebaugh that contained defendants Rangel and Velazquez. Both Rangel and Velazquez are felons with previous convictions in the State of Washington. Once the Sheriff deputy was able to search the vehicle, he discovered them to be in possession of two firearms, one of which had been reported stolen. In addition to the firearms, there were three altered fire extinguishers in the vehicle that were filled with varying amounts of fentanyl laced pills that weighed in excess of 15 pounds.

If convicted of all charges and allegations, both Rangel and Velazquez face a sentence of up to 20 years in state prison.

Rangel and Velazquez were arrested on August 15th, 2022, and thereafter booked into the Fresno County Jail. They are scheduled to be arraigned on August 18th, 2022, at 8:30 AM in Department 20 of the Fresno County Superior Court.
