However, because of the Internal Revenue Code (IRC) restrictions, in most cases, the fair market value of your registered DP or their children's (if they are not federal tax dependents) healthcare coverage will be taxable to you as imputed income. This value is determined by the amount that the employer pays in premium for registered DP coverage. This amount raises your taxable gross income. Also, the payroll deductions to cover a registered DP must be taken on an after-tax basis.
