# CLEAN SLATE PROGRAM

### Your Privacy Matters.

The information you share in your application is kept strictly confidential and will only be accessed and shared by those directly involved in processing your application and petition. We use this information solely to assist with clearing your record, internal statistical tracking, and external data reporting requirements.

### How to Apply

Due to high demand, we can only assist those who submit all required information. We will not be able to move forward with your application if the below steps are not completed.

### Step 1: Obtain your criminal history

Fill out the below California Department of Justice Live Scan Form and Fee Waiver and go get your fingerprints taken. **Cost:** The cost for fingerprints is a separate charge and ranges from \$25-\$40 and we encourage you to shop around for the most affordable location.

### Step 2: Submit an application that includes your fingerprint results

There are two steps to filling out the application. (1) Submit a copy of your criminal history and (2) Submit application.

### Step 3: Program Assessment and Eligibility

Once our review of your application is complete, we will contact you via email or by letter telling you whether we can help you. If you are eligible for our services, we will schedule a telephone appointment to move to the next part of the process.

**Please wait at least six (6) months before calling or emailing regarding the status of your application. We are appointment only and do not accept walk-ins.**
