6. You do not have any pending charges or outstanding warrants.
7. You are not on parole or have completed at least half of your probation term; and,
8. Have your California Department of Justice (DOJ) rap sheet, Local Criminal History Record or Superior Court case numbers.

Be Prepared:

8. Request a copy of your Department of Justice (DOJ) Rap Sheet, or,
9. If all of your convictions are from Tulare County, request your local Criminal History Record from the Tulare County Sheriff's office.
10. Find out if you owe any fines, fees, or restitution for your criminal cases.
11. Gather receipts, copies of background checks, proof of community service, or completion of programs or education.

4. You have a felony conviction for:
 - Possession of Methamphetamine H&S 11377
 - Possession of Controlled Substance H&S 11350
 - Possession of Cannabis H&S 11357(a)
 - *Receiving Stolen Property P.C.496
 - *Forgery P.C. 470-476
 - *Fraud/Bad Checks P.C.476a
 - *Commercial Burglary of Store During Regular Business Hours P.C. 459
 - *Theft Offenses P.C.487, 484e, etc.
 - *Petty Theft/Shoplifting with prior(s) P.C. 666

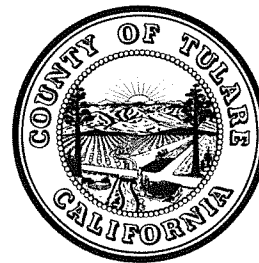
*Offenses involving amounts of \$950 or less.

Proposition 64 cases

5. You have a felony conviction for:
 - H&S 11357, 11358, 11359, 11360

Possible Clean Slate Options:

1. Reduce felonies to misdemeanors for qualifying offenses.
2. Early termination of felony or misdemeanor probation.
3. Dismissal of case when probation is complete
4. Dismissal of infractions.
5. Dismissal of local prison cases.
6. Certificates of Rehabilitation for state prison and P.C. 290 cases.
7. Reclassification of specified felonies. (Prop 47) (Prop 64)
