Bidding Logistics – Jessica Navarro

- Renovations are complete on the 7th floor and our conference room is now open to the public during bid openings. Bid openings are also still viewable via Zoom and the livestream link will be posted on the website.
- Contractors have the option of using Bid Express to submit an electronic bid. Any hardcopy bids or hardcopy bid bonds can be dropped off at the office.
 - It helps us ensure we are available to receive them if you email tracking numbers to DesignServices@fresnocountyca.gov. If you are dropping off documents prior to the bid opening day, it helps us make arrangements to receive them if you call 559-353-4919 to let us know.
 - Scans of hardcopy bid bonds are now accepted as electronic bid bonds at time of bid opening but if you don't use Tinubu or Surety2000, you will need to get the original hardcopy of the scan to us before 4:00 PM on the fifth (5) calendar day after the bid opening.
- Subcontractor details are required at the time of bid opening and a list of what is required is provided at the top of the Subcontractor List (Proposal 8) and full, complete details are due within twenty-four (24) hours of bid opening.
- While DIR registration must be up to date and paid at the time of bid, the DIR website has stated a *temporary* pause of enforcement, so *if you have a DIR registration, please provide it* but, we will not prevent any contractors or subcontractors from being awarded a contract because of these issues.
- CARB Certificates of Reported Compliance for the prime contractor must be submitted prior to the time of the bid opening. Subcontractors' certificates can be submitted within five (5) calendar days of the bid opening.
