- Contractors have the option of using Bid Express to submit an electronic bid. Any hardcopy bids or hardcopy bid bonds can be dropped off at the office.
 - o It helps us ensure we are available to receive them if you email tracking numbers to <u>DesignServices@fresnocountyca.gov</u>. If you are dropping off documents prior to the bid opening day, it helps us make arrangements to receive them if you call 559-353-4919 to let us know.
 - Scans of hardcopy bid bonds are now accepted as electronic bid bonds at time of bid opening but if you don't use Tinubu or Surety2000, you will need to get the original hardcopy of the scan to us before 4:00 PM on the fifth (5) calendar day after the bid opening.
- Subcontractor details are required at the time of bid opening and a list of what is required is provided at the top of the Subcontractor List (Section 004336) and full, complete details are due withing twenty-four (24) hours of bid opening.
- Department of Industrial Relations (DIR) registration must be up to date and paid for at the time of bid.
- CARB Certificates of Reported Compliance for the prime contractor must be submitted prior to the time of the bid opening. Subcontractors' certificates can be submitted within five (5) calendar days of the bid opening.
