### 5. Questions

Questions can be submitted in writing via the Request for Clarification (RFC) form on the project website and responses to previously asked questions are posted to the project website.

1. In the RFP, it states that the site plan, floor plan, exterior elevation, and schematic designs have been developed and are not subject to change. As the

design progresses, how will potentially necessary design changes be coordinated?

A: Any possible modifications to the design will be managed through Capital Projects.

2. Will the Design-Build Entity have a chance to meet with library staff to better understand the program?

A: During the selection phases (RFQ and RFP), questions about the project can be submitted via the Request for Clarification (RFC) form on the project website. After the final selection of the Design-Build Entity, all communication related to the project will be coordinated through Capital Projects.

3. Do you have a total project budget or estimated project value?

A: The estimated value for both projects combined is \$32,000,000-\$36,000,000.

Oral explanations or interpretations of plans and specifications are not binding. Any explanation, interpretation or clarification of plans and specifications will be in the form of a written addendum to the plans and specifications issued to the planholders of record.

It is the Contractor's responsibility to ask any questions they might have regarding this project. No allowance will be made after the bids have been received for any errors or omissions due to any misconceptions made by the Contractor.
