#### ANALYSIS/DISCUSSION:

The Board of Supervisors has approved their calendar of Board Hearing dates. Having this information certain, Staff has prepared the attached proposed 2024 Planning Commission Hearing Calendar that provides for 19 hearing dates. Seven months (January, February, March, April, June, August, and October) have been provided with two hearings for purposes of agenda flexibility. The proposed Calendar has the same number of hearing dates as in 2023. Hearing dates may be cancelled, as necessary, if there are not enough agenda items to warrant the meeting.

Any potential Joint Hearing dates with the Board of Supervisors will be scheduled as needed, pending coordination with the Clerk of the Board, and have not been included on this Calendar. The Commission will be advised of any upcoming or pending Joint Hearings if and when those dates are scheduled. Also, should the Department determine that a special hearing is necessary, staff will solicit the Commission in advance to determine availability prior to scheduling.

Attached as Exhibit 1 is the proposed Calendar of Planning Commission Hearing dates. Staff has already coordinated with the Clerk of the Board's Office to ensure that the dates provided will not conflict with use of the Board Chambers and tentatively reserved the chambers in anticipation of the Commission's conformation of the calendar. This advanced scheduling is intended to avoid having to hold meetings off site due to the chambers not being available.
