REQUEST:

Determine General Plan Conformity of Fresno Unified School District's proposal to acquire property comprised of three parcels totaling approximately 17.75 acres, for construction of agricultural education facilities for Sunnyside High School in the AL-20 (Limited Agriculture, 20-acre minimum parcel size) Zone District, and the R-1-B(nb)(Single Family Residential, 12,500 square-foot minimum parcel size, Neighborhood Beautification Overlay) Zone

District.

LOCATION:

The proposed acquisition area is located on three adjacent APN's, located at the southwest corner of the intersection of E. Kings Canyon Road and S. Minnewawa Avenue, between E. Kings Canyon Road and E. Lane Avenue, adjacent to the city limits of the City of Fresno, (APNs: 472-022-12, 13, 05) (748 S. Minnewawa Ave., 810 S. Minnewawa Ave., and 1010 S. Minnewawa Ave. (Sup. Dist. 3).

## PLANNING COMMISSION ACTION:

At its hearing of May 18, 2023, the Commission considered the Staff Report and testimony (summarized in Exhibit A).

A motion was made by Commissioner Chatha and seconded by Commissioner Arabian to determine that acquisition of the proposed school site was in conformance with the Fresno County General Plan. The motion to determine conformance pass on a vote of 5 to 0.
