a. General history of the districts.

3. Citizens Advisory Committee (CAC) Update

- a. 7/21/2022 CAC meeting: Marsha Waller, Sheldon Sandstrom, & Jeff Hixon were voted in as CAC members. It was later determined that Sheldon Sandstrom did not meet the bylaw requirements.
- b. Peter Van Vleet was confirmed as Chair.

c. The CAC currently has 3 vacancies. Doug Koerper nominated by current CAC members. An election will be held in September. Anyone interested in volunteering can contact Cybil Luna at cluna@fresnocountyca.gov.

4. Projects & Repairs

- a. CSA 31B
 - i. County staff provided update regarding aging lift stations and increased need for emergency maintenance.
- b. Shaver Lake Wastewater Treatment Plant Creek Fire Repairs
 - County staff is working with CalOES on reimbursement for repairs made due to Creek Fire Damage. Up to 70% of expenses may be reimbursed. All repairs have been completed.
- c. Capacity Analysis WWD 41W, WWD 41S, and CSA 31B.
 - i. Consultant is being hired to study the capacity and condition of water and wastewater systems in the Shaver Lake area in order to identify deficiencies, recommend improvements, and assess ability to serve existing and future development.

d. WWD 41W

- i. Timberwine hydro-tank replacement completed.
- ii. Ridgetop water storage tank is offline and needs to be replaced. WWD41W cannot afford to do so until after Prop 218 rate adjustment.
- ARPA Water Meter Replacement Project: projected completion date of 8/29/2025.

e. CSA 31

- i. CAC requested County staff to research whether CSA 31 funds can be used to help fund construction of the new fire station.
- ii. CAC requested County staff to have Community Center Parking Lot assessed for resurfacing.

iii. County staff to research the responsible party for the potential

remodel of the Community Center indoor bathrooms and ADA

parking.

5. Financial Status

Reviewed current financials for all districts.

a. WWD 41W - Shaver Lake Water: Operating at a deficit. Reserves

depleted. Prop 218 rate adjustment anticipated in Fiscal Year 25-26.

b. WWD 41S - Shaver Lake Sewer: Prop 218 rate adjustment anticipated

after WWD 41W Prop 218 process is completed.

c. CSA 31B – Shaver Lake Village & Camp Edison Sewer: Prop 218 rate

adjustment anticipated after WWD 41W Prop 218 process is completed.

d. CSA 31 - Shaver Lake Rec & Fire: Potential projects may necessitate a

future Prop 218 rate adjustment.

6. WWD 41W Boundary Change & Rate Adjustment

County staff provided an update on the status of an administrative boundary

change. The County is in the process of formally merging nearby CSAs that are

already served by WWD 41W into the district. This adjustment will not change

the number of customers served but will streamline how water services are

organized and administered.
