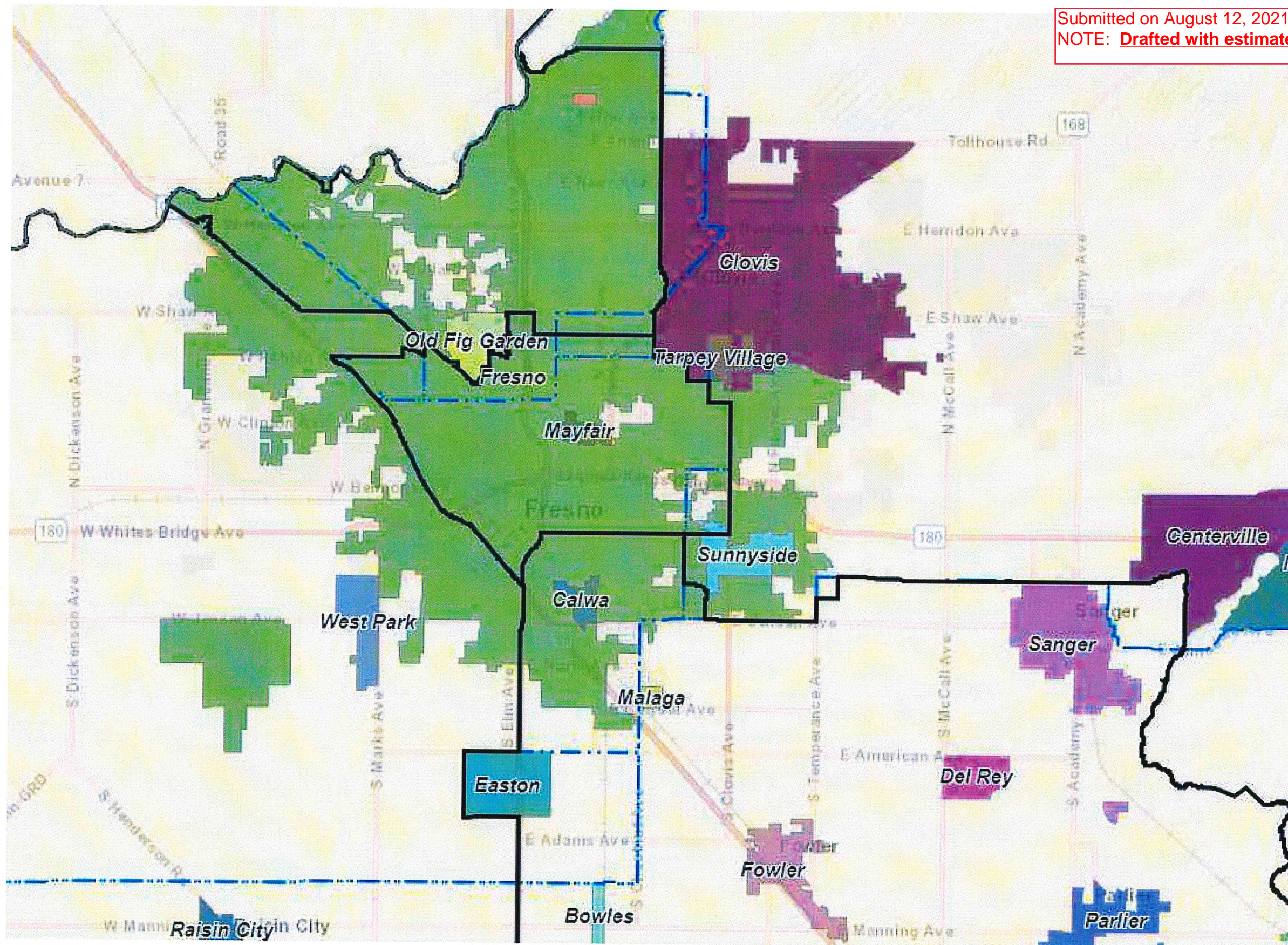

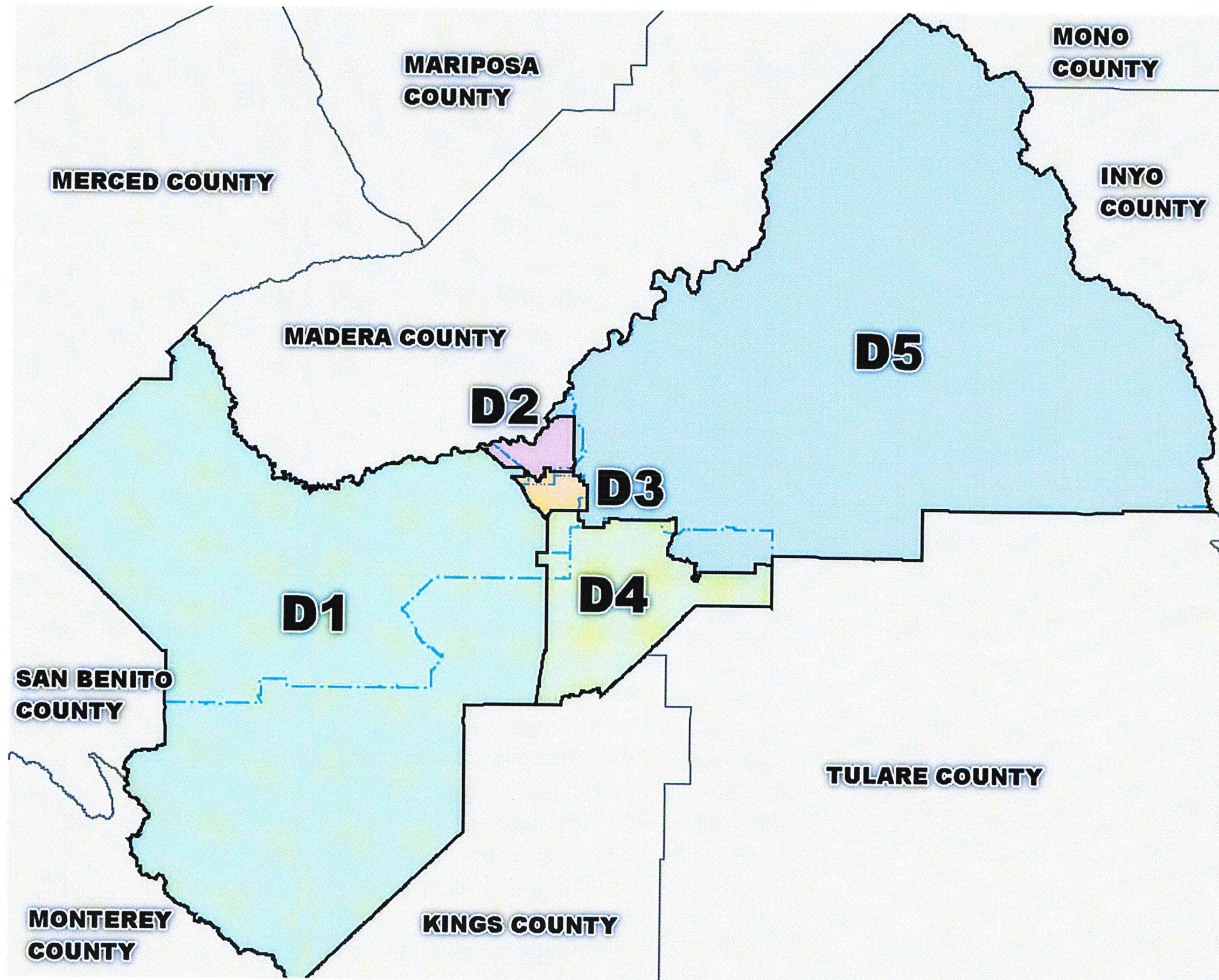

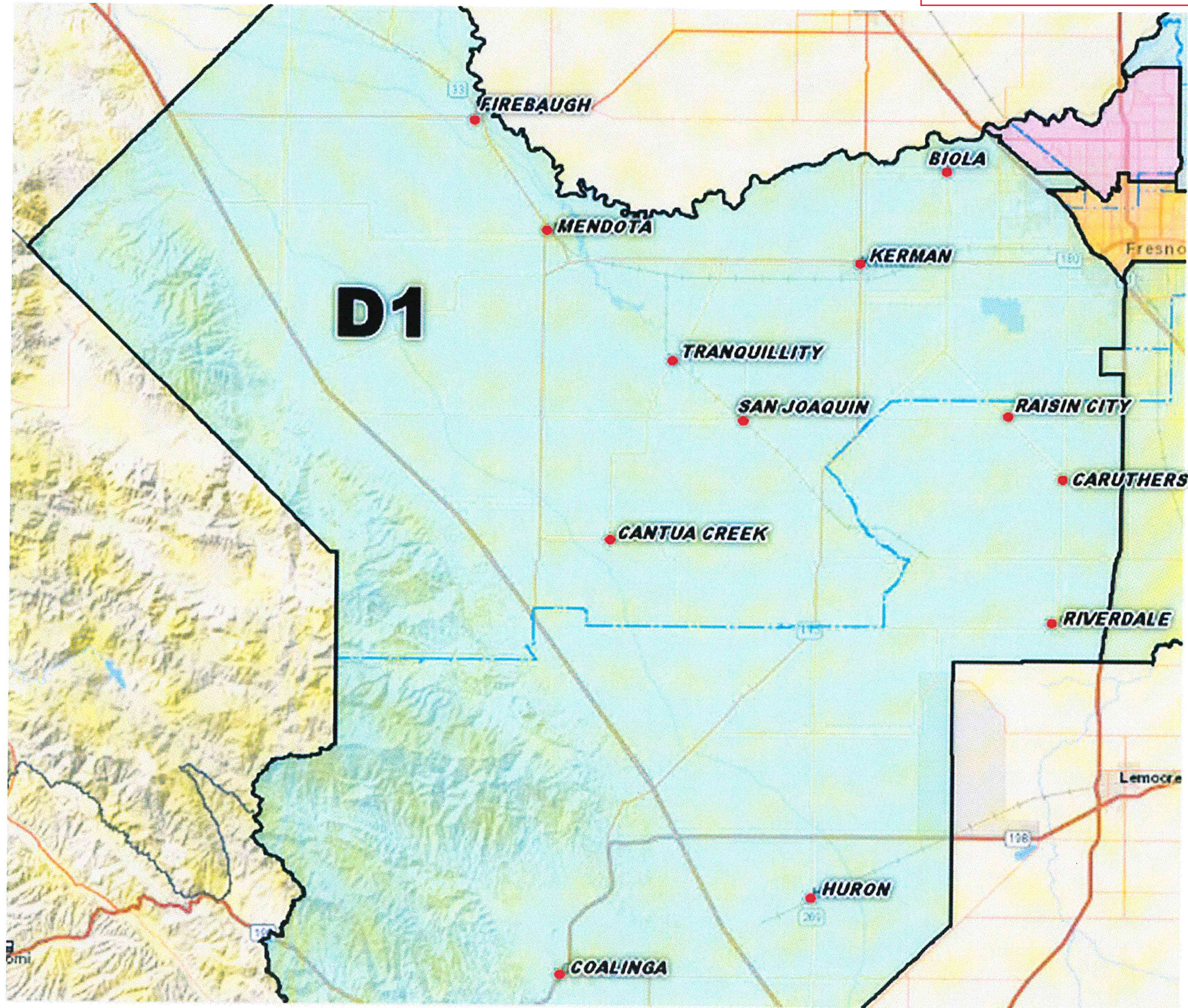
*Overall View of Equity Coalition Map for Fresno County Redistricting 2021.*

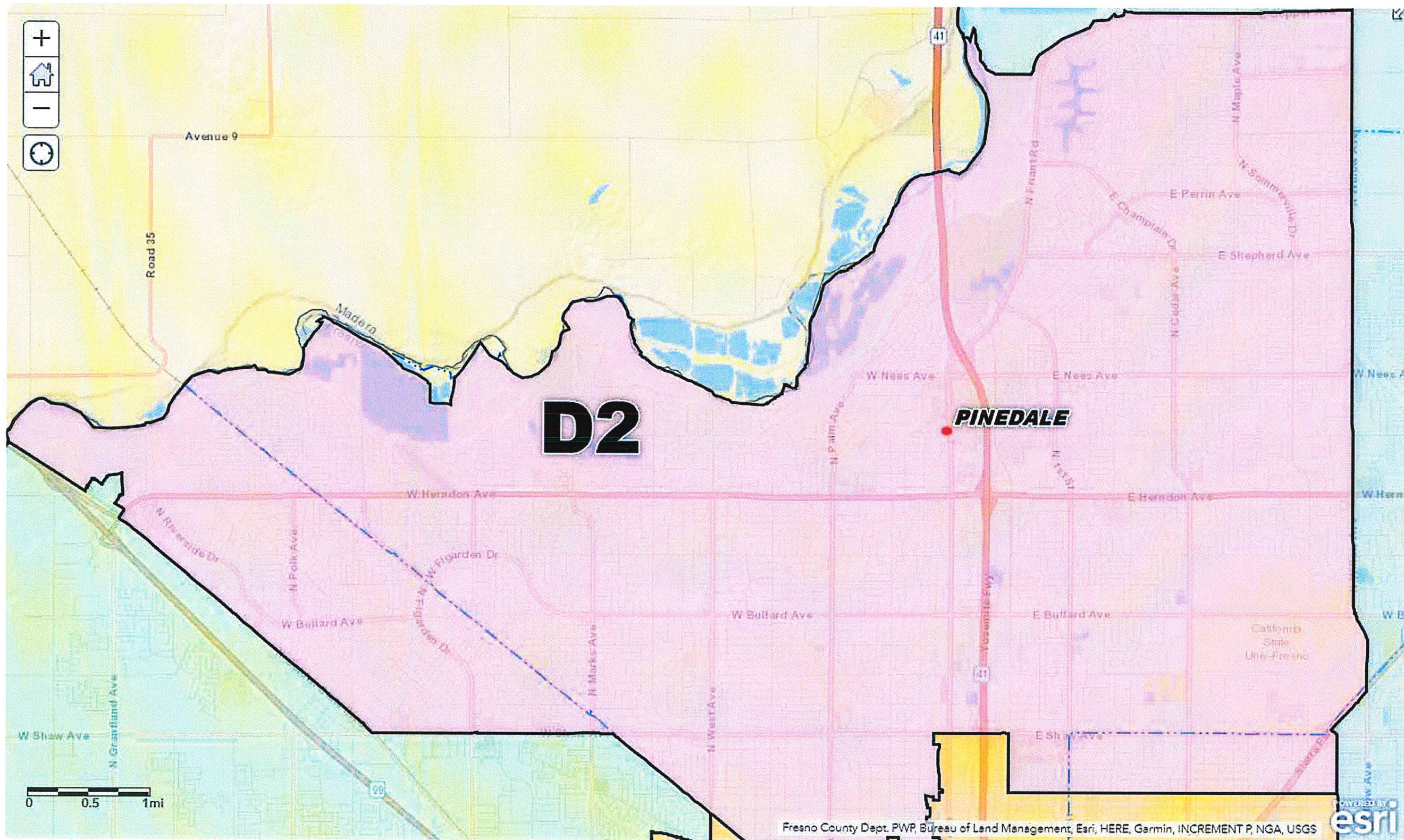

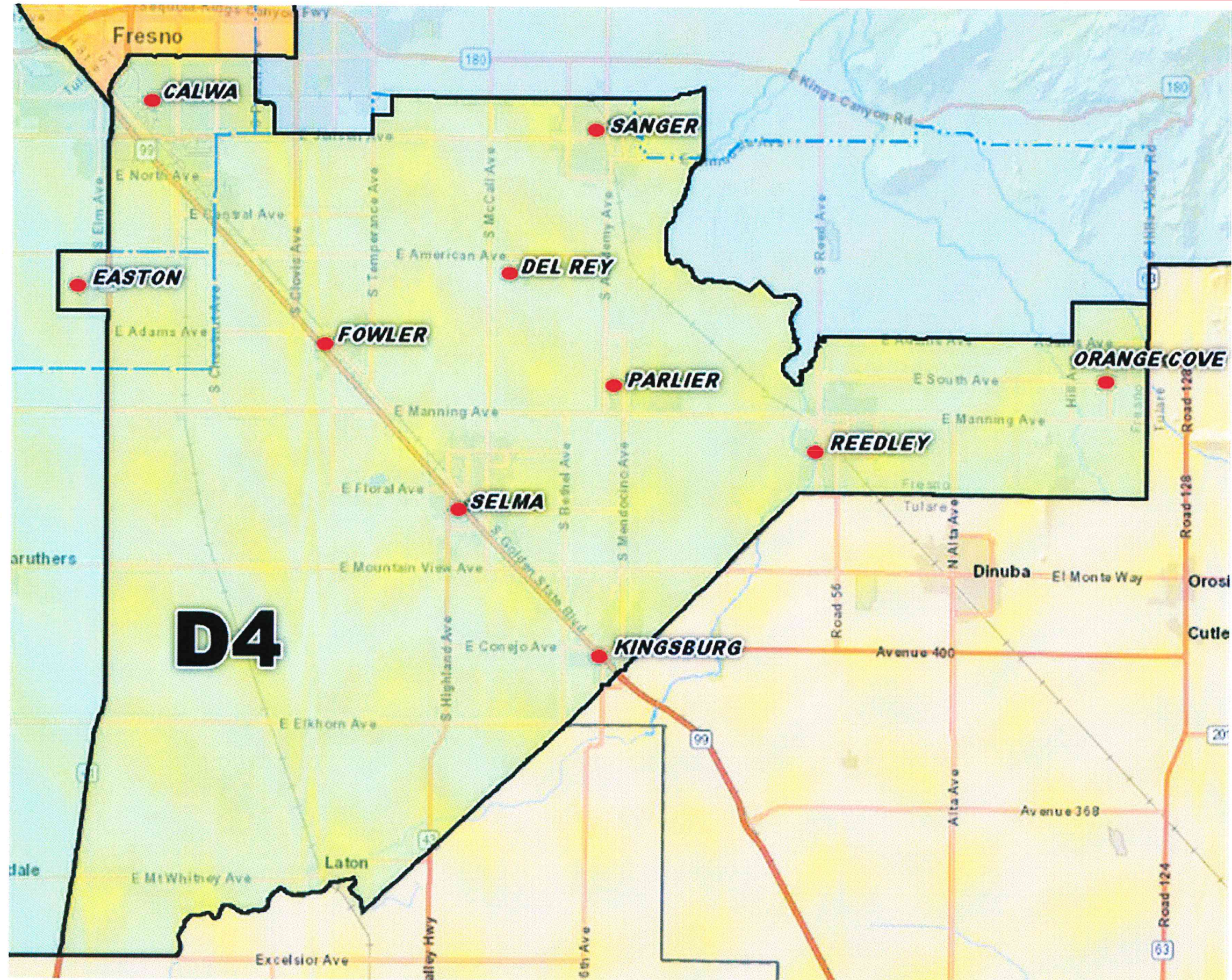

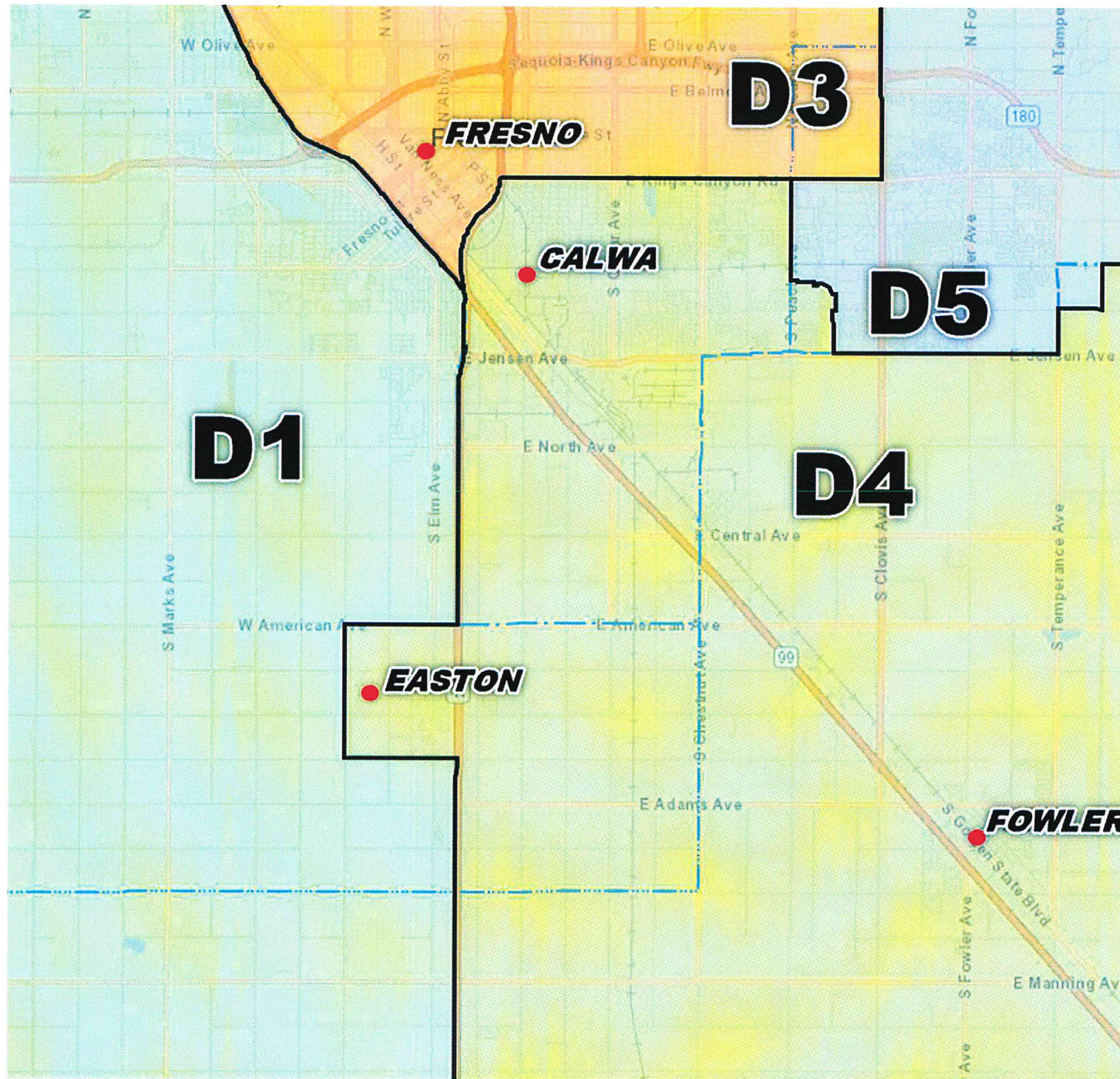

# District #4 – Detail of District #4 – Calwa & Easton

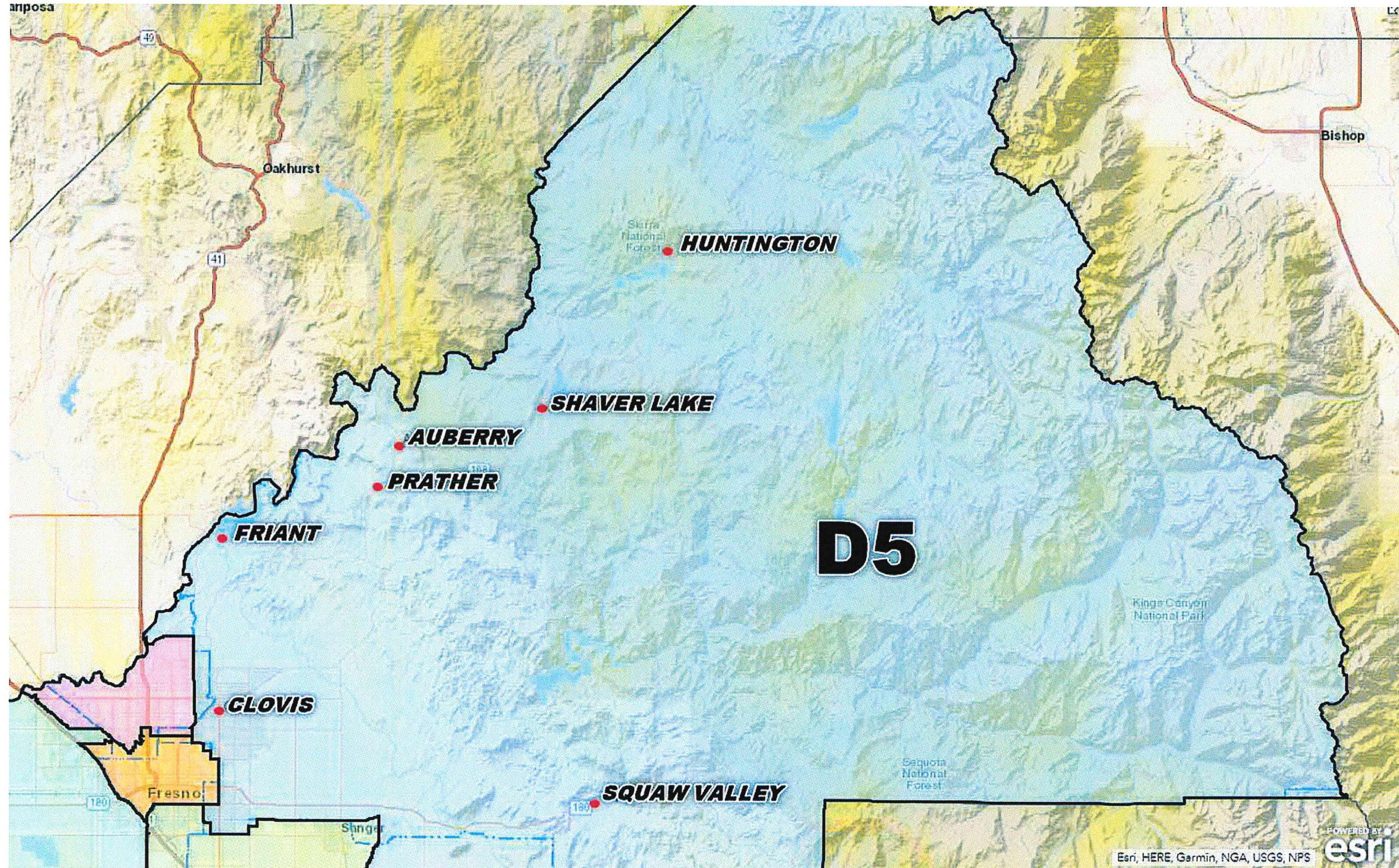

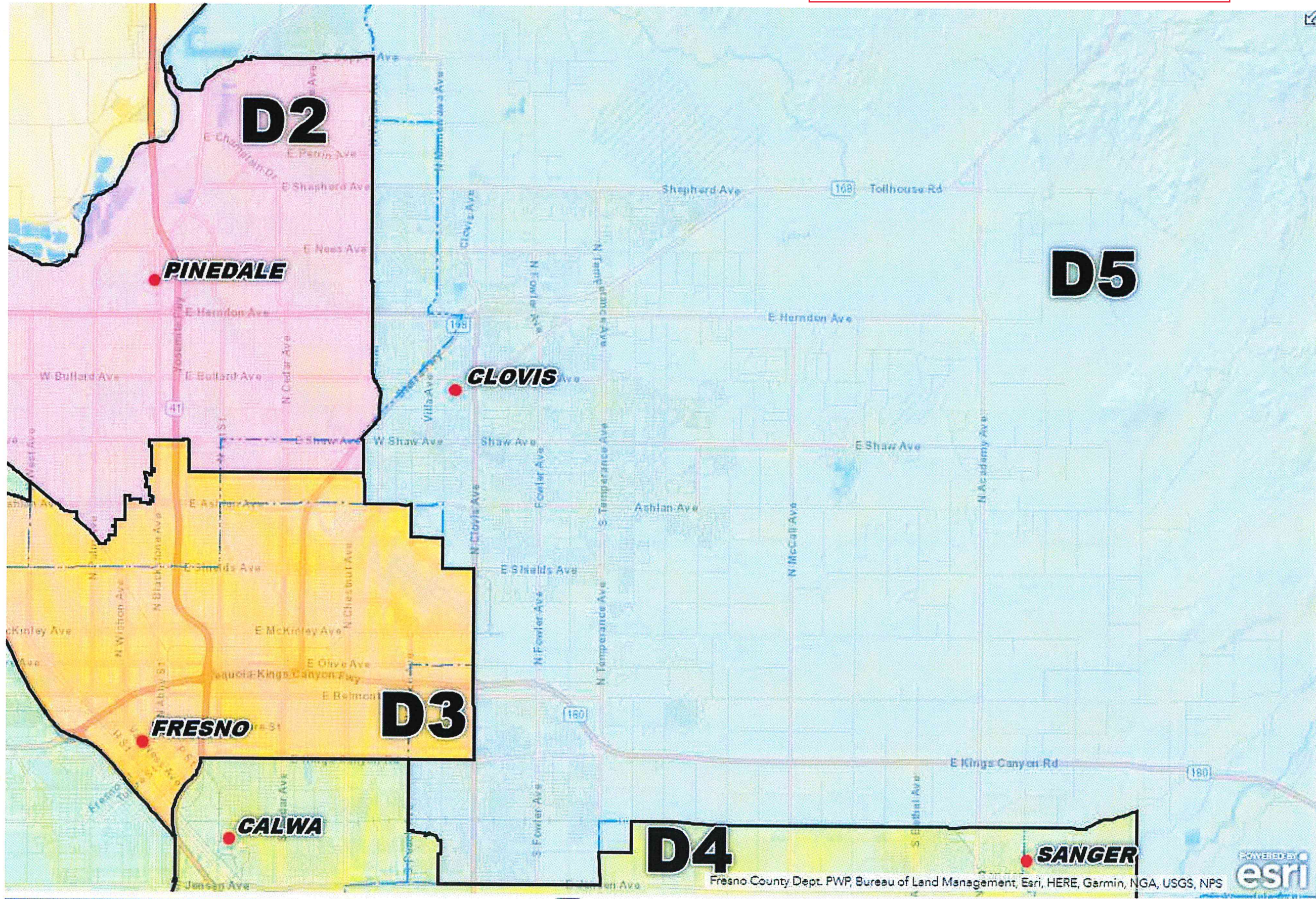
