E-forms will be available soon.

Overdue applications update: 3464 previous month, 2930 overdue 5 overdue from 2024 and are scheduled. Jan- March 468 due April – June 1560

July- started 50/50 penalty split with state and Fresno Co. working to get penalty to zero. Fee is monthly with a quarterly due date.

Elsa-reports 10 new staff expected to be fully boarded next month.

Erica- 6 full staff – small application back log as there was only two staff. 4 staff filled OA vacancies. Staff came from child welfare and will be approaching 1 year mark.

Erica reports 15-minute wait time for call center.

Last month 10,000 phone calls where taken. 1,000 applications taken.

CFCO cases have been increased due to a federal audit by by Centers for Medicare & Medicaid (CMS) noted that individuals ranked 3 or 6 in bowel & bladder care were not included in the CFCO funding criteria. 650 cases are over due to the audit.

CDSS Telehealth Reassessment letter ACL 25-55 noted counties can start with telehealth reassessments in their business processes. Individuals can opt out of a telehealth reassessment and have in person reassessments.

The questionnaire will be sent to the recipient via the same way they currently review/approve timesheets, either the ESP or they can respond by answering the questions in the TTS (if TTS they will get a paper copy of the questions in the mail too). Responses to the questionnaire will assist the SW to determine whether a recipient is eligible. Questionnaire consists of the following questions:

- 1. Interested in a telehealth assessment?
- 2. Can use telephone/video calling devices independently or with assistance?
- 3. Emergency/urgent care visit within the last 3 months?
- 4. Admitted to care facility for 24 hours in the last 3 months?
- 5. Health/safety referral (APS, police, other) since last assessment?
- 6. Receives other case management services (like CVRC, MSSP, HCBA/WPCS)?

Important to know that the recipient must have opted to participate in a telehealth reassessment, have access to and able to use technology for a video or phone conference (or with some assistance from others), and must be able to provide responses on their own behalf.

Some education may be needed for Authorized Reps that have access to the recipient's ESP account and respond to the questionnaire affirmatively. If the recipient is dependent on the AR/DR to interact with IHSS, they are not eligible for a telehealth reassessment.

Telehealth eligible interviews will depend on a criterion. No minors, no hospitalizations in the last year. No changes to the IHSS worker. Not reported to APS in the last year.

Upcoming changes to Medi-Cal from HR 1 that will have an impact on some IHSS recipients

 1/1/26 - Reinstating Asset Limits (\$130, 000 & 65,000 per household member (max 10)

- DHCS has to submit a State Plan Amendment to reinstate asset limits but does not anticipate any issues. Activities to meet the implementation date are already occurring.
- Persons receiving Medi-Cal through Pickle, Disabled Adult Child (DAC) or Widow/Widower will not be impacted until 1/1/27.
- 1/1/26 Medi-Cal Expansion Freeze for Adults 19 & Older without Satisfactory Immigration Status (SIS)
 - Directly impacts Medi-Cal beneficiaries with a Medi-Cal Full Scope Expansion (M1 aid code) who do not have SIS
 - Will have to renew every 6 months
 - Does not apply to Newly Qualified Immigrants under the fiveyear bar, Qualified Non-Citizens (Title 8 USC §1641(b)), individuals claiming to be Permanently Residing in the US Under Color of Law (PRUCOL), the Medi-Cal Access Program, or the Medi-Cal Inmate eligibility Program.

O. <u>Director's Report</u>

State wants to control the collective bargaining for IHSS. Hope to have the change effective in 2026 but may be in 2029 or 2030 realistically.

HR 1/ Medicare targeted eligibility not in President's Big Beautiful Bill. Individuals receiving Medicare without satisfactory immigration status will pause as of 01/26.

Current individuals will remain aided. New individuals may pay a bill, has not been decided.

Medi-cal very limited. ACA was created to open to all people. New bill and admin working to restrict access.


