2. **INITIAL STUDY APPLICATION NO. 7325** and **CLASSIFIED CONDITIONAL USE PERMIT APPLICATION NO. 3582** filed by **PATRICK MADDOX**, proposing to allow the expansion of an existing dairy to include an increase in animal units, new structural improvements and a new anaerobic digester with related power generation facilities on an approximately 84.3-acre portion of a 346.79-acre parcel and an 11.3-acre portion of a 240-acre parcel in the AE-20 (Exclusive Agricultural, 20-acre minimum parcel size) Zone District. The project site is located on the southeast corner of W. Davis and S. Chateau-Fresno Avenues approximately 2.6 miles southeast of the unincorporated community of Burrel (7285 W. Davis Ave., Riverdale CA) (SUP. DIST. 4) (APN 053-050-52S; 053-180-07S). Adopt the Mitigated Negative Declaration prepared for Initial Study Application No. 7325, and take action on

Classified Conditional Use Permit Application No. 3582 with Findings and Conditions.

3. **VARIANCE APPLICATION NO. 4040** filed by **PETE COHRS**, proposing to allow the division of a 107-acre parcel to create a 96-acre parcel (Parcel A) and an 11-acre parcel (Parcel B), in both the AL-20 (Limited Agricultural, 20-acre minimum parcel size) and O (Open Space) Zone Districts. A Variance is required to allow both parcels to be created with less than five acres of Open Space Zoning, and a Variance is required to allow the creation of Parcel B with less than 20 acres of AL-20 Zoning. The subject parcel is located east of South Riverbend Avenue and north of the Kings River, approximately two miles east of the nearest limits of the City of Sanger. (SUP. DIST. 5) (APN 333-041-33). Staff has determined that the subject proposal is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Section 15061(b)(3) - *Review for Exemption*.
