#### **Duties/Responsibilities of the QIC:**

Recommend policy decisions; review and evaluate the results of QI activities, including performance improvement projects; institute needed QI actions; ensure follow-up of QI processes; and document QI Committee meeting minutes regarding decisions and actions taken.

#### **Objectives:**

- 1. Engage all MHP staff members in the use of QI techniques and reflect improved value to clients.
- 2. Incorporate and support preparations for Organized Delivery System Waiver approval, Final Rule and 1915(b) Special Terms and Conditions, and Commission on Accreditation of Rehabilitation Facilities Certification CARF).
- 3. Utilize the Annual QI Work Plan, and Evaluate the QI Work Plan annually.
- 4. Utilize essential QI tools to interpret and process data such as *Plan, Do, Study, Act, Fishbone, Driver Diagram, Flow Charts*, and *Run Charts*.
- 5. Maintain two Performance Improvement Projects (Clinical/Non-Clinical) using QI techniques that increase the value of the projects for the agency and deepen the skills and capability of the QI team to serve as QI coaches.
- 6. Deploy measures based on clinical tools and capabilities to improve measurement of system performance and generation of value to clients.

**Delegation of Authority:** QIC committee members provide recommendation of finding, outcomes, results, reports to QIC.
