Urgent Care Wellness Center (UCWC) is an outpatient treatment center that provides assessment, treatment planning, individual and group counseling, and linkage to community resources. UCWC is often

considered the "front door" for adult mental health services at Fresno County as most new persons served will contact UCWC to begin services. Additional access activities include

wellness groups, vetting full service

partnership referrals, 1370 evaluations and liaison services to community partners

including but not limited to probation, parole and Central Valley Regional Center (CVRC).

The allocated positions for the program consists of 14 Mental Health Clinicians, 5 Community Mental Health Specialists and 2 Peer Support Specialists. The program operated at an average vacancy rate of 14%

throughout FY 17-18.
