Declaration of Candidacy forms may be obtained in the office of the Fresno County Clerk/Elections, 2221 Kern Street, Fresno, California, 93721, beginning July 18, 2016, and must be filed in that office no later than August 12, 2016, 5:00 pm.

To obtain additional Candidate Filing information, call the Fresno County Clerk/Elections office at 559-600-VOTE (8683) or access the website at www.co.fresno.ca.us/elections.

Appointment to each elective office will be made, as prescribed by California Elections code Section 10515, in the event there are no nominees or an insufficient number of nominees for such office and a petition for an election is not filed within the time period prescribed by said Section 10515.
