UNCLASSIFIED CONDITIONAL USE PERMIT APPLICATION NO. 3662 filed by STEPHEN SHEHADEY, proposing to amend approved Conditional Use Permit (CUP) No. 3580 in order to allow the installation and operation of a Bloom Fuel Cell Energy Server. INITIAL STUDY APPLICATION NO. 7029 and UNCLASSIFIED CUP APPLICATION NO. 3512 filed by GRANITE CONSTRUCTION COMPANY, proposing to allow the expansion of an existing aggregate mining operation on a 299.11-acre parcel in the AE-20 (Exclusive Agricultural, 20-acre minimum parcel size) Zone District in the unincorporated area of the County of Fresno and on a 202.54-acre parcel in the MBL (Light Manufacturing/Business) Zone District in the City of Coalinga. The project site is located on the north side of Cambridge Avenue, between Monterey Avenue and State Route 198/33, adjacent to and within the city limits of the City of Coalinga (38940 Highway 33, Coalinga) (SUP.
