Announcement was made regarding the current Mental Health Awareness campaign of "Driven by Hope". All were invited to write a personal message of hope on a small disc provided. Later all the discs collected will be put together, creating a mosaic design of hope for all to read while on display in one of the downtown County buildings.

    February -

Items Previously reported on at the January meeting for February, remain the same, with the addition of closure of the Family Development Center.

- The center was associated with Pathways to Recovery
- Was Funded by the Department of Social Services (DSS)
- Included services delivered by The Department of Behavioral Health (DBH) on behalf of DSS
- Outsourced treatment component
- The need for the type of early childhood services did not align with the rest of the Department target population that was discovered by a large decrease in referrals

### March -

- Amendment to Department of Healthcare Services Substance Abuse Prevention and Treatment (SAPT)
- Dreamcatchers Empowerment Network and California Department of Rehabilitation – Vocational and Educational Services
- Application for Mental Health Student Services Grant
- Master Agreement Horticultural Gardens

#### Statewide Updates -

Medi-Cal Healthier California for all – Previously known as Cal-Aim

- Workgroups assigned to the redesign will conclude in March
- Waiver language will be developed through Spring 2020
- Proposal for 1915 (b) waiver will be submitted in late Spring/early Summer
- If approved, it will be rolled out over 5 years, beginning January 2021

### Whole Person Care -

A State one-time allocation to initiate Whole Person Care-Like pilots in counties to the target population of persons experiencing homelessness with serious mental illness, substance use disorder and/or other chronic physical health conditions. The Department of Behavioral Health, County Administrative Office, Public Health and Social Services will all play a role in contributing to the pilot while working with an \$894,377 state allocation for Fresno county

# b. Report on Children's Behavioral Health Services, including All 4 Youth Youth Wellness Center Services

- Serves as a "front door" for access to Children's Mental Health
- Provides access to service and care coordination for all children/families seeking services on all levels of care
- Provide immediate connection to psychiatry services when needed
- Individuals may receive assistance navigating medical resources available in Fresno County as a walk-in, through a referral or by calling the 1-800 access line.
- While the Department is responsible for Medi-Cal beneficiaries, individual in need can receive assistance in care coordination accordingly with a proper match for the type of insurance carried
- A post-hospital team provides a follow-up to clients after psychiatric hospitalization

### All 4 Youth – Implementation Update

- Department of Behavioral Health (DBH) Fresno County Superintendent of Schools (FCSS) Partnership Program
- Five-year rollout to onboard all school districts of Fresno County
- First school districts to receive was based on utilization data
- Currently moving on to the third year of onboarding and already serving:
  - \*\* 26 School Districts
  - \*\* 120 Schools
  - \*\* 5 Charter Schools

# c. Report on Contracted Psychiatric Health Facilities <u>CBHC</u>

- For adults only
- Serves 49% of total psychiatric hospitalizations of Fresno County Medi-Cal beneficiaries

- Program is well documented
- Well departmentalized and responsive to all questions

# d. Re-establishment of Substance Use Disorder (SUD) Subcommittee

The former SUD subcommittee was suspended due to no BHB members able to chair. Current BHB member Amanda Boone has expressed interest and proposed re-establishing the subcommittee. Amanda is employed with Fresno Impact as a Peer Goal Recovery Specialist and invited anyone interested in the re-establishment to discuss it with her after the meeting. Amanda's vision for the subcommittee includes:

- Discussion of topics regarding SUD, roadblocks or struggling issues
- Program/meeting wheelchair accessibility
- Education on drug Medi-Cal, life skills and job preparation

- Physical health conditions that may affect ability to attend activities
- Help find more resources of Alcoholics Anonymous (AA), Narcotics Anonymous (NA) and activities for individuals in sobriety
- Create or locate Access Points and recovery residences

Amanda will work out details of meeting location, date and times for a meeting every two months with a goal to begin conducting meetings in either April or May of this year 2020. BHB members support the proposal of re-establishment of the committee to learn about and network topics on SUD resources for members of the community.

At the meeting on February 3<sup>rd</sup>, 2020 a presentation was given by The Independent Living Association (ILA). The Independent Living Association supports operators of Independent Living Homes, also known as Room and Boards.
